Aggiornamenti sulle condizioni di Hasan Firouzi e Mohammad Ekhtiarian

I due giovani uomini, arrestati nel corso delle proteste seguite alla morte di Mahsa Amini, sono entrati in coma.

Rapporti di attivisti iraniani per i diritti umani indicano che un manifestante detenuto a Shahr-e Rey, a sud di Teheran, è entrato in coma a causa di gravi torture. (Shahr-e Rey in teoria dovrebbe essere un carcere femminile, più noto come Qarchak women's prison. Informazioni precedenti indicavano che Firouzi fosse detenuto a Evin. Entrambe le prigioni sono nei dintorni della capitale Teheran, ndt).

Gli attivisti affermano che Hasan Firouzi (anche scritto Hassan Firouzi) è caduto in coma venerdì (20 gennaio) a causa delle torture, delle emorragie e della mancanza di cure.

L'uomo di 34 anni è stato brutalmente torturato dopo essere stato arrestato durante le recenti proteste, e un tribunale rivoluzionario lo ha condannato a morte (vedi NtC 21/12/2022).

La ong "Iran Human Rights Monitor", con sede in Francia, ha annunciato il 16 gennaio che Hasan Firouzi aveva detto che il suo "unico desiderio" era vedere sua figlia prima dell'esecuzione.

Il rapporto afferma che Hasan Firouzi, durante gli interrogatori è stato duramente picchiato con una sedia, ha avuto gravi emorragie, e non essendo stato curato ha perso la funzionalità del rene sinistro.

Nel frattempo, l'avvocato di uno dei manifestanti detenuti a Khorramabad, nell'Iran occidentale, ha affermato che il suo cliente è caduto in coma a causa di un'infezione dovuta alle ferite riportate durante l'arresto.

"Il mio cliente, Mohammad Ekhtiarian, uno degli arrestati nel corso delle recenti proteste, è in coma a causa dell'infezione delle ferite causate subite l'arresto", ha scritto sulla sua pagina Instagram.

Secondo l'Iran's Prisons Atlas, Mohammad Ekhtiarian è un bodybuilder e durante le proteste seguite alla morte di Mahsa Amini è stato ferito a una gamba da proiettili della polizia e poi arrestato.

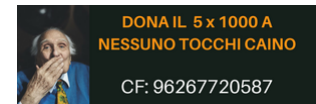

Hasan Firouzi, one of those arrested during the protests, is in danger of execution. The prison officials told the family: the death sentence has been referred to the execution headquarters, “we will inform you one day before the execution”!

Iranian Human Rights Society, Wednesday, December 21, 2022; Hassan Firouzi, one of the detainees of the protests, has faced the threat of execution. According to an informed source, when Hassan Firouzi’s family went to Evin prison, they were told that the death sentence had been issued for Hassan. And it has been referred to the execution department and we will wait until his

An informed source told the Iranian Human Rights Society: "Following this news, some members of Hassan Firouzi's family decided to self-immolate under very difficult conditions."

It is said that Hasan Firouzi was "tried" in a completely unfair manner and sentenced to death in Ray City Court in Sa'i Square. It is said that the prosecutor's representative in Hassan Firouzi's court is the same person who was also present as the prosecutor's representative in Mohsen Shekari's court. He was accused of "leading protests, preaching against the regime, disrupting security, etc.". And with the same accusations, he has been sentenced to death.

After being tortured, he was taken to the hospital for treatment on December 14. And despite the doctor's prescription that he should undergo surgery, IRGC intelligence agents brutally attacked the hospital. And he was stolen from the hospital and transferred to the solitary cell of Evin prison.

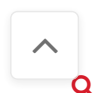
Due to the strong blows of the chair on Hasan Firouzi's body, his left kidney has failed. Hasan suffered severe internal bleeding.. But he was left in the solitary cell of Evin prison without medical treatment. And he may die at any moment.

According to the news that received from the prison, Hassan's hands and face badly injured and bruised.

On December 17, Hassan Firouzi was transferred from the solitary cell of Evin prison to an unknown place. This is while Hasan has been severely tortured. And according to the news that came from the prison, Hassan's hands and face were badly injured and bruised.

Finally, when the family went to Evin prison, they were told to leave here. His death sentence has been sent to the execution department and we will inform you one day before the execution.

Hassan Firouzi has a baby named Hanane, who was 18 days old when he was arrested in October. On October 27, he was arrested in Tehran's Enghelab Street and accused of "leading protests and propagandizing against the regime". He was first released on bail and was arrested again on November 26 and tortured.

Hassan announced in an audio file that all his belongings were stolen and recorded. He said that the accusations against him were completely false.

According to local witnesses, Hassan Firouzi's house was sealed by the government agents. And his family has also been asked to evacuate and leave their house immediately.

Also, Hassan Firouzi's family was told that he tried to commit suicide in prison, but the prison officers stopped him. This is while Hasan had announced before his arrest that he did not intend to commit suicide and that he would try his best to survive for the sake of his daughter.

Now Hassan Firouzi's life is in serious danger of execution and his family is also in a very difficult situation. We ask all societies and human rights organizations and the United Nations Human Rights Council to take urgent action to stop the crime in Iran.
