Mojgan Keshavarz had been previously sentenced to 23 years and six months in jail for opposing the compulsory Hijab

Women's rights activist Mojgan Keshavarz faces the trumped-up charge of "corruption on earth," which could be punished by the death penalty.

Mojgan Keshavarz is an opponent of the compulsory Hijab. She had previously received a sentence of 23.5 years in 2019 for openly opposing the mandatory Hijab but was temporarily released due to illness which made prison conditions unbearable.

Her lawyer, Mohammad Moghimi, announced on January 17 that "the life of Mojgan Keshavarz is in danger." A new case has been filed against her on the charge of "corruption on earth," Mr. Moghimi said.

Mojgan Keshavarz, who has a 12-year-old daughter, was arrested at home in Tehran on April 25, 2019. She was beaten in front of her daughter and subsequently taken to an unknown location. Just before being arrested, Ms. Keshavarz was working as a volunteer to help the flood-stricken residents of Lorestan.

Ms. Keshavarz and two other Hijab protesters, Yasaman Aryani and Monireh Arabshahi, were sentenced to 55 years and six months in prison. The Revolutionary Court of Tehran informed Yasaman Aryani, Monireh Arabshahi, and Mojgan Keshavar of their sentences in the absence of their lawyers on July 31, 2019.

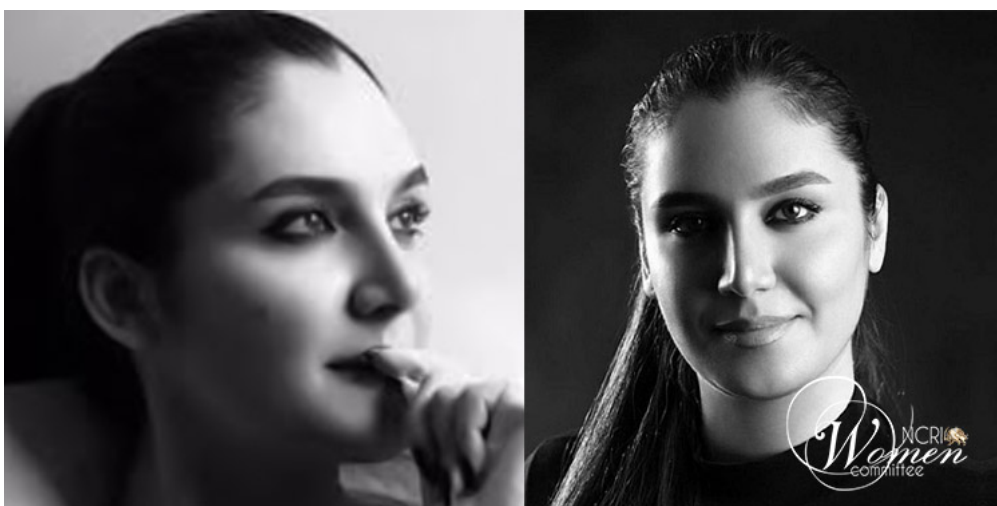

Mojgan Keshavarz

Branch 28 of Tehran's Revolutionary Court, presided by the notorious judge Mohammad Moghiseh, **sentenced** each of these prisoners to 5 years in prison for "assembly and collusion against national security," one year for "disseminating propaganda against the state," and ten years for "encouraging and preparing the grounds for corruption and prostitution."

In addition to these charges, Mojgan Keshavarz has been sentenced to 7.5 years for "insulting the sanctities." These add up to **55 years and six months** in prison for women's rights activists.

Amnesty International issued a statement on the three women's rights activists whose arrests are related to a video clip showing them **handing flowers** to women in a metro wagon on International Women's Day. Amnesty International wrote, "Making criminals of women and girls who refuse to wear the hijab is an extreme form of discrimination."

Mona Heydari's killer sentenced to 8 years and 3 months in prison

In a shocking development, while Ms. Keshavarz has been sentenced to more than 23 years in prison for opposing the mandatory hijab, and the protesters arrested for setting fire to the garbage can are facing death sentences and life imprisonment, the husband of Mona Heydari, who cut off his wife's head and paraded in the streets with it, was sentenced to 8 years and two months in prison on January 18.

At 3 p.m. on Saturday, February 7, 2022, Sajjad Heydari, Mona's husband and cousin, marched in Khashayar Square in Ahvaz, the capital of Khuzestan province in southwest Iran. With a dirty grin, he held Mona's head in his hand.

Mona Heydari, whose real name is Ghazal and who was only 17 years old, was forced into marriage at age 12 and had a 3-year-old son who now lives with his grandmother.

Mona was a victim of **domestic violence**. She had filed for divorce several times, but her family persuaded her to continue living with her husband for the sake of her child. Eventually, Mona fled to Turkey to escape her husband's violence.

According to Abbas Hosseini Pouya, the prosecutor of Ahvaz, Mona's father returned her to Iran. When her husband found out Mona was in Ahvaz, he dared to kill her. (The state-run IMNA news agency – February 8, 2022)

5/7/2020 According to HRANA, 35 political women prisoners are currently being kept in the women's Evin Prison ward. They face problems such as limited access to medical services, rarity and high prices of goods, low-quality food, etc. After the coronavirus's pandemic, prisoners are responsible for preparing masks and gloves. In the prison store, each mask or pair of gloves is sold to prisoners at a price of between eight and ten thousand tomans. Detergents and disinfectants are also given to the prisoners rationally. Still, the prisoners have to buy these materials from the store due to the lack of these items. The prison store sells Alcohol and other disinfectants at high prices, so some prisoners buy these substances together. The quality of food is low, and most prisoners are forced to buy food from the prison store. Maryam Akbari Monfared, Atena Daemi, Raheleh Ahmadi, Saba Kord Afshari, Niloufar Bayani, Sepideh Kashani, Fatemeh Mosanna, Zahra Zahtabachi, Monireh Arabshahi, Yasaman Ariani, Mojgan Keshavarz, Aras Amiri, Samaneh Norouz Moradi, Nasrin Sotoudeh, Hengameh Shahidi, Rezvaneh Ahmad Khanbeigi, Sepideh Farhan, Sepideh Gholyan, Maryam Ebrahimvand, Neda Ashtiani, Zahra Jamali, Fariba Adelkhah, Mozhgan Kavousi, Mozhdeh Negahdar, Elham Barmaki, Masoumeh (Minoo) Ghasemzadeh Malek Shah, Maryam Haji Hosseini, Nazanin Toosi, Mina Saki, Mira Radpour, Leila Raouf, Hajar Siamifar, and Soroush Ahmadi Khosravi are among the 35 women prisoners currently being kept in the women's ward of Evin Prison.

5/2/2020 Branch 54 of Tehran Court of Appeals, presided over by Judge Babaei, sentenced Yasaman Ariani, Monireh Arabshahi, and Mozhgan Keshavarz to five years and six months in prison on the charge of "encouraging corruption and immortality," three years and six months for "Assembly and planning against national security," and to seven months for "propaganda against the system." According to Article 134, five years and six months of imprisonment will apply to them. The appellate court was held without the lawyer and the defendants.

6/11/2019 America Abroad Media Organization awarded Iranian-American Journalist Masih Alinejad. She declared that she is presenting the award to four women's rights activists: Monireh Arab Shahi, Mojgan Keshavarz, Yasaman Ariyani and Saba Kord Afshari, during her speech at this gathering. by appreciating their activities, she additionally introduced them as <>.

31/7/2019 According to Hrana's reporting, Branch 28 of the Revolutionary Court, headed by Judge Moghise, sentenced women rights activists and opponents of compulsory Hijab Yasaman Ariani, Monire Arabshahi and Mojgan Keshavarz to a total of 55 years in prison which, after the application of Article 134 reductions, will be a total of 30 enforceable years. Their convictions consist of the following: One year for "propaganda against the regime", Five years for "collusion and gathering for acting against national security" and 10 years for "encouraging and facilitating corruption and prostitution". Mojgan Keshavarz has also been sentenced to seven years and six months in prison on the charge of "insulting the sacred". During the trial, Mr. Moqise told the three that they won't have access to lawyers before the verdict was issued. He also repeatedly hurled insults at them.

29/7/2019 After political prisoners protested the late medical attention shown to Saba Kord Afshari whose transfer to a clinic was delayed, they were beaten up by prisoners held on drug charges (this had been demanded by clinic authorities.) The following political prisoners were injured in this clash: Yasaman Ariani, Neda Naji, Atefe Rangriz and Sepide Qolijan. The day after, Saba Kordafshari, Yasaman Ariani, Monire Arabshahi and Mojgan Keshavarz staged a protest in front of the prison office.
