Fazel and Mehran Bahramian in danger of execution at any moment

After a few days of not knowing, the lives of Fazel and Mehran Bahramian are in danger in Dastgerd prison of Isfahan

According to the Iran Human Rights Society, on Wednesday, January 31, 2024. Fazel and Mehran Bahramian are currently in solitary cell in Isfahan's Dastgerd prison, facing the threat of execution. According to an informed source, these two prisoners have had no contact with their families for four days and their families are in ignorance and anxiety about the latest situation of their loved ones.

On January 29, 2024, Fazel and Mehran Bahramian, who sentenced to death for "Moharebeh and acting against national security", transferred to solitary cells in Isfahan's Dastgerd prison. They not allowed to contact or visit their families. On the same day, the families of the two political prisoners summoned and threatened not to protest anything and not to media the news related to their children.

Today, Wednesday, January 31, is the second day that the people of Samirom have gone on strike in protest of the death sentence. And transfer of these two prisoners and have not opened their shops.

Fazel and Mehran Bahramian arrested in 2022.

Fazel Bahramian, born in 1989, married with a two-year-old son, is a mechanic and had a car repair shop before arrested. He is the brother of Morad Bahramian, a martyr of the freedom path, who killed by security forces in the nationwide uprising in 2022.

Mehran Bahramian, born in 1993, is single. His father has passed away and Mehran is the head of the family.

During the nationwide uprising in 2022. On November 16, security forces shot and killed Ali Abbasi, Morad Bahramian, Muslem Houshangi and Milad Asefi. On December 31, 2022, during the nationwide uprising, security forces arrested Fazel Bahramian in his private home in Samirom. He severely tortured.

In the same month, Mehran Bahramian also arrested. Fazel and Mehran Bahramian transferred to solitary cells of the Intelligence Department in Isfahan. This is located in Dolatabad, 10 days after their arrest. They then transferred to the Alpha cells in Dastgerd prison in Isfahan.

Fazel and Mehran Bahramian severely tortured, so much so that Mehran Bahramian's teeth broke and his eardrum ruptured. Fazel Bahramian also injured in the head and face during interrogation and torture.

On January 25, 2024, the Samirom Court of Appeal confirmed the death sentence of Fazel and Mehran Bahramian. He previously sentenced to death for "Moharebeh and acting against national security".

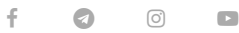

Iran Sentences Two More Protesters To Death

Human rights sources have reported that Mehran and Fazel Bahramian, two Iranian protesters, have been sentenced to death, the latest among Iran's killing spree.

According to reports from Dadban, a group of pro-bono lawyers in Iran defending political prisoners and rights activists, the two protesters have been condemned to death in Semirom, Esfahan province, on charges of Moharebeh or "waging war against God."

Dadban further reveals that the two, detained since January last year, have endured severe torture, with Mehran Bahramian suffering broken arms and legs under torture.

Their arrests stemmed from their involvement in a fortieth-day ceremony honoring deceased protesters and their alleged connection to the death of a security officer named Mohsen Rezaei.

Fazel Bahramian's brother, Morad Bahramian, is counted among the victims of nationwide protests.

Despite domestic and international criticism, the judiciary of the Islamic Republic persists in handing down death sentences to protesters and political detainees.

The recent spate of executions in Iran has triggered a barrage of condemnation from human rights activists and global organizations. Vedant Patel, Deputy Spokesperson for the US Department of State, **denounced the Iranian government's suppression tactics**, highlighting the lack of democracy and transparency within its political system.

Earlier this month, **the UN experts disclosed that** at least 834 individuals were executed in Iran in 2023, with eight of them linked to nationwide protests. Urgently calling on the Iranian government to cease the ongoing wave of executions, the experts demanded a reassessment of the country's use of the death penalty.

Businesses Strike To Protest Heavy Charges Against Iran Protesters

Businesses in Semirom city in Esfahan Province have gone on strike in protest to heavy charges against two local political prisoners.

Regime security and intelligence forces have framed Fazel and Mehran Bahramian for the murder of an IRGC Basij militia gunman during anti-government protests in the city last December.

The two were arrested in January after the government killed their brother Morad in November. Their detention was apparently aimed to silencing the family. Now they are being accused of killing the Basij member, Mohsen Rezaei, and face charges that could result in the death penalty.

The streets of Semirom witnessed a surge of protests on December 31. Security and military forces were heavily deployed throughout the city at the time. The paramilitary Basij force member, Mohsen Rezaei, allegedly died in clashes.

Hundreds of special police forces were deployed to Samirom starting January 1.

Several people, including Abbasi's sister and Bahramian's two brothers, were arrested during raids on the victims' families.

A source told IranWire that Fazel and Mehran Bahramian, a relative named Younes Bahramian, and another man named Dariush Saadi were tortured to extract confessions on the alleged murder of the Basij militiaman.
