Execution Of Another Protester Sparks Outrage Among Iranians

The execution of Milad Zohrevand, a young Iranian protester on Thursday, has shocked and angered anti-government activists and dissidents in Iran and abroad.

Zohrevand was secretly executed in the Malayer prison in the western province of Hamedan while his family were not allowed to see him for one last time. Hengaw Human Rights Organization said in a statement that Zohrevand had not been notified that his execution.

The 21-year-old was married and became a father while serving time in prison. It is not clear if he ever had the opportunity to see his newborn child before his death.

In June, Zohrevand was sentenced to death in connection with the "murder" of an IRGC officer named Ali Nazari during the nationwide uprising against the Islamic Republic. Zohrevand was arrested by security forces on October 26, 2022, at the height of the anti-regime protest movement, triggered by Mahsa Amini's death in the custody of the hijab police.





Gohar Eshghi, the mother of the 35-year-old blogger Sattar Beheshti, who was killed under torture in Evin prison 11 years ago, released a video message after the Zohrevand's execution.

"You're right; you start working at five in the morning. At the time of the call to morning prayer, you execute the youth or kill them under torture," Eshghi said in the video, addressing Supreme Leader Ali Khamenei, "do not kill these young people."

Executions take place around the time of Muslim dawn prayer in Iran. The time for the call for dawn prayer (called azan or adhan) is now associated with executions for Iranians.



Despite the claims made by the Iranian judiciary, no video has been released so far showing how the IRGC officer was killed. According to human rights activists and organizations, there are many contradictions in the charges levelled against Zohrevand.

Iran's judiciary and security officials provided different and even contradictory data regarding the number of suspects that were arrested in relation to the "murder" of the IRGC officer.

Zohrevand was reportedly accused by prosecutors of being one of a group of five masked men who shot the IRGC intelligence



Information received by Iran International indicates that Zohrevand was denied access to a lawyer and other basic rights of an accused throughout his detention. His family was also under intense pressure from the IRGC intelligence service not to make public statements about his case.

The execution comes two weeks after UN Secretary-General Antonio Guterres released a report highlighting a surge in executions in Iran.

According to the report, at least 419 people were executed, including 409 men and 10 women, between January 1, 2023 and July 31, 2023, marking a 30 percent increase compared to the same period last year. Iran is second only to China in the number of executions carried out annually.

At least eight people have been executed by the Iranian regime for their involvement in nationwide protests triggered by the death in custody of Mahsa Amini in September 2022.

Iran secretly executes man over 2022 anti-government protests - sources

If confirmed, Milad Zohrevand would be the eighth protester to be executed in the past year

Iran has secretly executed a man sentenced to death in connection with last year's anti-government protests, sources have told BBC Persian.

Milad Zohrevand, 21, was put to death on Thursday morning at a prison in the western city of Hamadan, they said.

Human rights group Hengaw also said it had received reports of the execution.

There was no confirmation from Iran's judiciary, which convicted Zohrevand of murdering a member of the Revolutionary Guards during a demonstration.

The sources said he was denied a lawyer throughout his detention and trial.

If confirmed, Zohrevand would be the eighth protester to be executed after last year's rallies.

A recent report by UN Secretary General António Guterres warned that in the seven previous cases, information "indicated that the judicial proceedings did not fulfil the requirements for due process and a fair trial".

It added: "Access to adequate and timely legal representation was frequently denied, with reports of coerced confessions, which may have been obtained as a result of torture."

The protests against Iran's clerical establishment erupted in September 2022 following the death in custody of Mahsa Amini, a 22-year-old woman who was detained by morality police for allegedly wearing her hijab "improperly".

Hundreds of people have been killed and thousands detained in a violent crackdown by security forces, which have portrayed the protests as "riots".

Two informed sources told BBC Persian that Milad Zohrevand was executed at Hamadan Central Prison at dawn on Thursday. But prison authorities had not handed over his body to his family by the afternoon, they said.

Hengaw, which focuses on Iran's Kurdish ethnic minority, said in a statement that Zohrevand had also not been notified that his execution was imminent or granted a final meeting with his family.

It strongly condemned the execution, which it said "not only violates the right to life but also egregiously infringes upon the human rights of the detainee and his family".

Hengaw also alleged that the Revolutionary Guards - a major military, political and economic force in Iran - had put pressure on authorities to carry out the execution.

It said this had happened without the explicit consent of the family of the officer whom Zohrevand was alleged to have killed.

Last week, <u>Hamadan's prosecutor said</u> a branch of the Supreme Court had confirmed the death sentence handed to a defendant convicted of the murder of Ali Nazari, a member of the Revolutionary Guards' intelligence service.

They did not identify the defendant, but legal collective Dadban cited sources as saying that it was Zohrevand. It also reported that his family had been pressured into not publicising his case.

Zohrevand was reportedly accused by prosecutors of being one of a group of five masked men who shot Nazari as he confronted students demonstrating at the Malayer Faculty of Medical Sciences in October 2022.

Iran is second only to China in the number of executions carried out annually.

The UN secretary general's report said Iran was carrying out executions "at an alarming rate", putting to death at least 419 people in the first seven months of the year. That is a 30% increase compared to the same period in 2022.

At the same time as human rights activists warned about the situation of Milad Zahravand, one of the protestors in danger of execution, the Hamedan prosecutor announced the confirmation of the verdict of one of the defendants in the case of the killing of one of the .intelligence agents of the Hamedan Provincial Guard in the Supreme Court of the country

Hossein Khanjani, the prosecutor of Hamedan city, told Tasnim news agency on Monday evening, November 22, close to the Revolutionary Guards, that "one of the branches of the Supreme Court issued a retribution verdict" against one of the accused in the killing of Ali Nazari, a member of the intelligence force of the Hamedan Revolutionary Guards. has .approved

Hamedan prosecutor, without mentioning the name of this defendant, added that after the death sentence was issued in the primary court, at the request of the defendant and the lawyer, the case was sent to the Supreme Court for appeal, but in the end, the judges of "one of the ."branches of the Supreme Court rejected the decision of the court." They approved the first one

Khanjani emphasized that currently the case of this person sentenced to death "is going through legal formalities to be sent to the General Justice of Hamedan province and execute the ."sentence

Mizan, the Judiciary News Agency, also reported on the evening of Monday, November 22, the "confirmation of the death sentence" of one of the detainees in this case in the Supreme Court, but it mentioned the name of the person sentenced to death, the branch of the trial court that .issued this sentence, and the branch that confirmed it. He did not in the Supreme Court

The news agency affiliated with the Judiciary also did not mention the time of the trial of those arrested in connection with the death of a member of the Malair Corps, but stated that in early 1402, a court in Hamedan issued a "death sentence" to one of the detainees under the title of . . ""retribution

Ali Nazari was one of the intelligence forces of Hamedan province's security forces, who died on November 4 of last year, during the suppression of street protests that were formed after the .gathering of students of Malayer Faculty of Medical Sciences

A day after this incident, Hossein Farsi, the special deputy governor of Malair, explained that this member of the Islamic Revolutionary Guard Corps and other security forces, when they were at the protest site, saw "about 5 people with their faces covered" in a car, but some of them . "with Seeing the police and security forces, they ran away

He added that "Ali Nazari approached one of the cars, which was a white Peugeot Pars, and opened the front door and observed that there was no one inside the car, but when he opened ".the back seat, a person was lying on the seat and was armed. He shot him

Tasnim news agency, however, stated in a more or less different story that "security forces, after a chase" with a car, stopped it "with shots" and Ali Nazari who approached the car and opened .it "with shots" One of the rioters was injured and died in the hospital

The security authorities of Hamadan province, including the deputy governor of Malair, announced the arrest of 6 people in connection with the case, and said that one of the people present at the scene is also a fugitive. has been

After that, on Tuesday, May 26th of this year, the account of "1500 Images" introduced one of the detainees in this case as "Milad Zahrevand" and wrote: "Milad was arrested with the fake scenario of "killing a government force" during the protests. And it is on the verge of (issuing) .the death sentence

This user account added that "Milad Zahravand was arrested on November 4, 1401 in Malair, and since that day no information about his physical and mental condition is available" and his ."family is also under "severe pressure

At the same time, the Dodban group, which provides legal advice to human rights activists, stated that "the Supreme Court of the country has confirmed the death sentence issued against Milad Zahravand, a 22-year-old young man from Malair", referring to the statements of the .Hamadan prosecutor on Monday night

Dodban added that Milad Zohrevand's death sentence was approved in the Supreme Court while "he was denied access to a lawyer during his detention" and the whole process of "holding his trial was done in less than three months" and "Milad Zahravand's death sentence has been .issued

This human rights legal consulting group also emphasized that during this period, "the family of Milad Zohrevand was strongly pressured by the IRGC Intelligence Organization not to ."inform about him

Over the past year, the judiciary of the Islamic Republic has executed seven people arrested during the nationwide protests of 1401, and the Iranian Human Rights Organization has warned that more than a hundred other protesters are in danger of issuing or executing death .sentences

Rights Group: Iran Secretly Executed Man in Case Related to 2022 Protests

PARIS — Iran secretly executed a man on Thursday after convicting him of killing a member of the security forces during mass protests that swept the country last year, rights groups said.

It was the eight execution Iran has carried out in a case related to the protests which erupted in September 2022 following the death in custody of Mahsa Amini, a young Iranian Kurd who had been arrested for allegedly violating Iran's strict dress rules for women.

Milad Zohrevand was executed at dawn in a prison in the western city of Hamadan, the Norway-based Hengaw organization said.

He had been sentenced to death for killing a Revolutionary Guards officer during a protest in the town of Malayer in November last year.

Hengaw, which focuses on Kurdish issues, said that Zohrevand had received no prior notification that his execution was imminent and was not granted a final meeting with his family.

The execution of Zohrevand, who was in his early 20s, has not been reported by media inside Iran.

The Dadban legal collective also confirmed the execution on social media, adding that Zohrevand had been denied a lawyer.

Iranian authorities have already executed seven men in cases related to the 2022 protests, drawing condemnation from human rights groups and Western governments.

The last such executions were of three men in May. Amnesty International said they were intended to "send a strong message to the world and the people of Iran that they will stop at nothing to crush and punish dissent."

Iran launched a sweeping crackdown to snuff out the protests that saw hundreds killed and thousands arrested, according to rights groups and the United Nations.

Iran has executed at least 680 people this year, mostly on murder and drug-related charges, according to Oslo-based group Iran Human Rights.

Secondo il gruppo Iran Human Rights con sede a Oslo, l'Iran ha giustiziato almeno 680 persone quest'anno, la maggior parte con accuse di omicidio e traffico di droga.

An informed source close to Milad Zahravand confirmed in an interview with BBC Farsi that his death sentence was announced on charges of "murder" and "self-revenge" and the sentence was "sent to the execution unit". For several days, concerns have been raised about the imminent possibility of Mr. Zohrevand's death sentence

In the past days, the name of Milad Zahravand, an arrested citizen from Malair, was widely published as someone who received a death sentence and is in danger of being executed, without

.any detailed information about him and his charges

Now, an informed source has informed BBC Farsi that Milad Zohrevand has been sentenced to death on the charge of "murdering" a member of the Islamic Revolutionary Guard Corps named "Ali .Nazari" during the 40th Mehsa (Zina) Amini protests

On the 4th of November last year, at the same time as the 40th of Ms. Amini, the students of .Malayer University protested based on the call that had been announced in advance

According to this source, Milad Zahravand "wasn't among the protesters", but he was present that .day for another reason at the place where an IRGC member named "Ali Nazari" was killed

A source who spoke to the BBC said that Milad Zohrevand was with several other members of his family near the police station of 12 Milair when a clash with the security forces took place: "Milad ".was shot in the hand and was seriously injured. This IRGC member was also killed there

The Ansar al-Hussein Revolutionary Guards of Hamadan province has introduced Ali Nazari to the .security-intelligence staff of the Revolutionary Guards in Malair

A day after this incident, several people who were with Milad Zahrevand were arrested. But Mr.

.Zohrevand was arrested after a week while "hiding" in Tehran

This source close to Mr. Zahravand tells the BBC that all the accused in the case were released on "bail", only he remains in prison and is the "main accused" in the case of the killing of a member of .the Revolutionary Guards

According to this knowledgeable source, the family of Milad Zohrevand has tried to get the consent of the family of this slain member of the Guards Corps by paying a very high ransom, but they insist on executing the sentence.

Milad Zohrevand was born in 2001 and is an asphalt worker. Married and while he was in prison, his "...child was born: "He hasn't seen his child yet

The killing of the Guards Corps cadre and three conflicting accounts of the authorities

There is no detailed information about the killing of Ali Nazari, but different authorities of .Hamadan province have presented different and contradictory accounts of how he was killed

On Thursday, November 5, 1401, one day after this IRGC cadre was killed in Malair, Ansar al-Hossein Hamedan's IRGC announced in a statement that he had been killed as a result of "chasing operations during riots" and announced the arrest of the perpetrators of his murder

Ansar al-Hussein Corps had announced the arrest of "five people" and the identification and prosecution of four others.

On the same day, Hossein Farsi, political and social deputy of the special governorship of Malair, said that seven people have been identified and six of them have been arrested

Based on this, the number of accused in the murder of Ali Nazari was announced as 9 people based on the announcement of the Islamic Revolutionary Guard Corps and 7 people based on the words .of the political and social deputy of Malair Governorate

Apart from this contradiction, the account of the political and social deputy of the special governorship of Malair about the killing of Ali Nazari is different from the account of the Ansar al-.Hussein army

In its statement, Ansar al-Hussein Corps did not mention how Ali Nazari was killed and simply .declared it as the result of a chase

However, Hossein Farsi told reporters how Ali Nazari, a member of the Malair Revolutionary Guard Corps, was killed as follows: "At 7:30 p.m., during a call to Faraja, they reported the presence of two suspicious vehicles on Shahid Mousavi Street. were sent After the security forces arrived at the place, they saw about five people with their faces covered, who were ready to leave, and some ran away when they saw the police and security forces. Shahid Ali Nazari approaches one of the cars, which is a white Peugeot Pars, and opens the door of the front seat and observes that there is no one inside the car, but when he opens the door of the back seat, a person lying on the seat is armed. ".He will shoot this martyr

In the narrative of the political and social deputy of the special command of Malair, contrary to the ."statement of Ansar al-Hossein Hamedan, there is no mention of "manhunting operations

In the continuation of his speech, Mr. Farsi declared the killing of Ali Nazari as the result of "calls of opponents, anti-revolutionaries and monarchists" who, according to him, "seek to create costs for ."the Islamic Republic system and insecurity and unrest

On the other hand, Hasan Razania, the political deputy for security of the Hamadan governor, on Wednesday, November 4, 1401, in an interview with the Tasnim news agency, close to the Guards Corps, explained the details of the killing of Ali Nazari as follows: "When the security forces were chasing thugs and There were mobs and some rioters, they started shooting, as a result of which ".one of the security forces was shot and killed

The narrative of Hamedan governor's political security deputy about the killing of Ali Nazari is .closer to what is stated in the statement of the Ansar al-Hussein army

In the latest news after the publication of reports about the impending execution of Milad Zohrevand in human rights media, such as Ha-Ngao and Page 1500 images that follow the news of the protests, on Saturday, July 3rd, Mohammad Reza Adalatkhah, the Chief Justice of Hamedan, in a press conference without mentioning the name of Milad Zohrevand Biyavard announced that "the case of the accused in the murder of an IRGC security officer was investigated in less than three months and his sentence of retribution was confirmed, and the case has been submitted to the "Supreme Court for review

Considering the contradictions that exist in the official reports and the words of the Hamedan province authorities about the manner in which Ali Nazari, the IRGC cadre and some of the defendants were killed, the speed of investigation of Milad Zahrevand's case raises concerns about

his execution, like other protesters who were executed in the same way in the past months. have .increased

According to an informed source of BBC Farsi, Milad Zohrevand was denied the right to have a .lawyer during the proceedings

.There is no information about how the Milad Zohrevand court was held

Milad Zohrevand (born 1381) is an Iranian citizen living in Malair . He was arrested and sentenced to death during the Iranian uprising of 1401 in Malair . He was an asphalt worker and his child was born while he was in detention. According to the government-affiliated media, he has been sentenced to death for the murder of a member of the Islamic Revolutionary Guard Corps named "Ali Nazari" during the 40th Mehsa Amini protests. [1] [2] [3][4] By announcing the transfer of this prisoner from Malair prison to Hamedan prison, Ha Ngao quoted an informed source and wrote that the security institutions told the family of this [5] political prisoner that his death sentence will be executed soon

On November 4, 1401, at the same time as the 40th of Mahsa Amini, the students of Malair University protested based on the call that had been announced in advance. According to his relatives, Milad Zahravand was not among the protesters, but on that day, for another reason, he was present at the place where a member of the Islamic Revolutionary Guard Corps named "Ali Nazari" was killed. He along with several other members of his family in There was a clash with the security forces near the 12 Milair police station. According to one of his relatives, "Milad was shot in the hand and was seriously injured. This IRGC member ".was also killed there

Ansar al-Hussein Revolutionary Guards of Hamedan province has introduced Ali Nazari as a member of the intelligence-security staff of the Revolutionary Guards in Malair. [1] However, so far no pictures or documents have been published by government institutions that show how this [3] member of the Islamic Revolutionary Guard Corps was killed, and there are contradictions about this case

Milad Zohrevand was deprived of access to a lawyer and other basic rights of an accused during the entire period of his detention, and during this period his family was strongly pressured by the IRGC Intelligence Organization to not inform about him. Also, there is no information available regarding the holding of his trial, but the head of justice of Hamadan province has announced the death sentence for Milad and sending the sentence to the Supreme Court . $^{[3]}$ Mohammad Reza Adalatkhah, the Chief Justice of Hamadan, also said without naming him, "the case of the accused was investigated in less than three months last year and his retribution sentence was confirmed, and the case was submitted to the $^{[5]}$ ". Supreme Court for review

The user account of 1500 images also announced that he was arrested and sentenced to death in November 1401 "with a fake scenario of killing a [4] .government force" in Malair

Hengaw warns about the possibility of executing Milad Zohrevand, a protestor from Malayer

Hengaw: Saturday, June 24, 2023

Milad Zohrevand, one of the detainees of the popular protests of Malayer city, who was previously sentenced to death by the judicial system of the Islamic Republic of Iran, has been transferred to the central prison of Hamedan, and there is a possibility that the death sentence of this political prisoner will be carried out.

According to the report received by the Hengaw Organization for Human Rights, during the last few days Milad Zohrevand, a 20-year-old political prisoner from Malayer City, was transferred from Malayer prison to Hamadan central prison.

According to an informed source close to Zohrevand's family, the Iranian security agencies have informed the family of this political prisoner that his death sentence will be carried out soon.

This political prisoner has been transferred to Hamedan prison today, Saturday, June 24, 2023, while the head of the Hamedan Justice Department, without mentioning the identity of this prisoner, has announced that he will be sentenced to death and that the case will be sent to the Supreme Court for confirmation.

Hengaw had reported earlier, quoting the relatives of the Zohrehvand family, that, although the family of Ali Nazari, the Iranian security guard who was killed during the protests in Malayer, has expressed their consent for a pardon, the IRGC has taken the family's representation with force and without the express consent of the family, they have demanded an immediate death sentence.

Milad Zohrevand was arrested on Thursday, October 27, 2022, during the public protests in Malayer City, by IRGC Forces along with five other citizens, and was later sentenced to death by the judicial system of the Islamic Republic of Iran.

It is worth mentioning that Milad Zohrevand was deprived of the right to access a lawyer, face-to-face meetings with family, and other basic rights of inmates during the entire period of his detention, even according to the minimum laws of the Islamic Republic.

While condemning and expressing deep concern, Hengaw calls for the immediate attention of human rights organizations to the situation of Milad Zahrevand to prevent any action in implementing the death sentence of this political prisoner.

پرونده میلاد زهرهوند؛ حکم اعدام به اتهام «قتل» یک عضو سپاه با سه روایت متناقض از مقامات

یک منبع آگاه و نزدیک به میلاد زهرهوند در گفتوگو با بیبیسی فارسی تایید کرد که حکم اعدام او به اتهام «قتل» و «قصاص نفس» اعلام شده و حکم «به واحد اجرای احکام ارسال شده» است. چند روزی است که نگرانیها درباره احتمال قریبالوقوع حکم اعدام آقای زهرهوند بالا گرفته است.

در روزهای گذشته نام میلاد زهرهوند، شهروند بازداشت شده اهل ملایر، بدون اینکه اطلاعاتی دقیقی درباره او و اتهامش وجود داشته باشد، به عنوان کسی که حکم اعدام دریافت کرده و در خطر اجرای حکم اعدام است، به صورت گسترده منتشر شد. اکنون یک منبع آگاه به بیبیسی فارسی اطلاع داده که میلاد زهرهوند به اتهام «قتل» یک عضو سپاه پاسداران به نام «علی نظری» در اعتراضات چهلم مهسا (ژینا) امینی به اعدام محکوم شده است.

چهارم آبان ماه پارسال، همزمان با چهلم خانم امینی، دانشجویان دانشگاه ملایر، بر پایه فراخوانی که از پیش اعلام شده بود، دست به اعتراض زدند.

فضای شهر ملایر هم متشنج بود و اعتراضات از عصر همان روز تا شامگاه ادامه پیدا کرد.

به گفته این منبع میلاد زهرهوند «در میان معترضان نبوده» است اما در آن روز به دلیل دیگری در محلی که یک عضو سیاه به نام «علی نظری» در آنجا کشته شد، حضور داشته است .

منبعی که با بیبیسی گفتوگو کرد میگوید میلاد زهرهوند به همراه چند نفر دیگر از اعضای فامیل خود در نزدیکی محوطه کلانتری ۱۲ ملایر بود که درگیری با نیروهای امنیتی اتفاق افتاد: «دست میلاد تیر خورد و بهشدت زخمی شد. این عضو سیاه هم آنجا کشته شد.» سپاه انصارالحسین استان همدان، علی نظری را کادر اطلاعاتی-امنیتی سپاه پاسداران در ملایر معرفی کرده است.

یک روز بعد از این واقعه چند نفر از افرادی که همراه میلاد زهرهوند بودند، بازداشت شدند. اما اَقای زهرهوند بعد از یک هفته در حالی که در «تهران مخفی شده بود»، بازداشت شد.

این منبع نزدیک به آقای زهرهوند به بیبیسی میگوید که همه متهمان پرونده با «وثیقه آزاد» شدند، تنها او در زندان مانده و «متهم اصلی» پرونده کشته شدن عضو سپاه پاسداران است.

به گفته این منبع اَگاه خانواده میلاد زهرموند تلاش کردهاند با پرداخت مبلغ دیه بسیار بالا رضایت خانواده این عضو کشته شده سپاه پاسداران را جلب کنند تا از حکم قصاص صرفنظر کنند، اما اَنها به اجرای حکم اصرار دارند.

میلاد زهرهوند متولد ۱۳۸۱ و کارگر آسفالتکاری است. ازدواج کرده و در زمانی که در زندان به سر میبرد، فرزندش به دنیا آمده است: «هنوز بچهاش را ندیده...»

کشتهشدن کادر سیاه پاسدران و سه روایت متناقض مقامات

از جزئیات کشته شدن علی نظری، اطلاع دقیقی در دست نیست، اما مقامهای مختلف استان همدان، روایتهای متفاوت و متناقضی از نحوه کشته شدن او ارائه دادهاند.

پنجشنبه ۵ آبان ۱۴۰۱، یک روز بعد از کشته شدن این کادر سپاه پاسداران در ملایر، سپاه انصار الحسین همدان طی بیانیهای کشته شدن او را در نتیجه «عملیات تعقیب و گریز در اغتشاشات» اعلام کرد و از دستگیری عاملان قتل او خبر داد.

سپاه انصارالحسین از بازداشت «پنج نفر» و شناسایی و تحت پیگرد قرار گرفتن چهار نفر دیگر خبر داده بود.

همان روز، حسین فارسی، معاون سیاسی و اجتماعی فرمانداری ویژه ملایر، گفته بود هفت نفر در این زمینه شناسایی و شش نفرشان بازداشت شدهاند.

بر این اساس، عده متهمان قتل علی نظری بر اساس اطلاعیه سپاه ۹ نفر و بر اساس صحبتهای معاون سیاسی و اجتماعی فرمانداری ملایر، ۷ نفر اعلام شد.

جدا از این تناقض، روایت معاون سیاسی و اجتماعی فرمانداری ویژه ملایر از کشته شدن علی نظری، با شرح سپاه انصار الحسین از این موضوع تفاوت دارد.

سپاه انصار الحسین در بیانیه خود هیچ اشارهای به نحوه کشته شدن علی نظری نکرده و صرفا آن را نتیجه تعقیب و گریز اعلام کرده است.

اما حسین فارسی در جمع خبرنگاران، نحوه کشته شدن علی نظری، کادر سپاه ملایر را اینگونه بیان کرد: « ساعت ۱۹:۳۰ طی تماسی با فراجا حضور دو خودرو سواری مشکوک در خیابان شهید موسوی را گزارش دادند که بلافاصله نیروهای فراجا و سپاه به محل اعزام شدند. نیروهای امنیتی پس از حضور در محل حدود پنج نفر را با صورتهای پوشیده مشاهده کردند که آماده حرکت بودند و با دیدن نیروهای انتظامی و امنیتی برخی فرار میکنند. شهید علی نظری به سمت یکی از خودروها که پژو پارس سفید رنگ بوده، نزدیک میشود و درب صندلی جلو را باز میکند و مشاهده میکند

کسی داخل ماشین نیست اما زمانی که درب صندلی عقب را باز میکند شخصی که روی صندلی دراز کشیده و مسلح بوده است به این شهید شلیک میکند.»

در روایت معاون سیاسی و اجتماعی فرامانداری ویژه ملایر، بر خلاف بیانیه سپاه انصار الحسین همدان، «از عملیات تعقیب و گریز» خبری نیست.

آقای فارسی در ادامه سخنان خود کشته شدن علی نظری را نتیجه «فراخوانهای معاندان، ضد انقلاب و سلطنت طلبها» اعلام کرد که به گفته او «دنبال ایجاد هزینههایی برای نظام جمهوری اسلامی و ناَمنی و اغتشاش هستند».

از سوی دیگر حسن رضانیا، معاون سیاسی امنیتی استاندار همدان، چهارشنبه ۴ آبان ۱۴۰۱ در گفتوگو با خبرگزاری تسنیم، نزدیک به سپاه پاسداران، جزئیات کشته شدن علی نظری را اینگونه شرح داد: «هنگامی که نیروهای تامینکننده امنیت در حال تعقیب و گریز اراذل و اوباش و برخی اغتشاشگران بودند، آنها شروع به تیراندازی کردند که بر اثر آن یک تن از نیروهای تامینکننده امنیت مورد اصابت گلوله قرار گرفته و به شهادت رسید.»

روایت معاون سیاسی امنیتی استاندار همدان از کشته شدن علی نظری به آنچه در بیانیه سپاه انصار الحسین آمده است، نزدیکتر است.

در تازهترین خبر بعد از انتشار گزارشهایی درباره احتمال قریبالوقوع اجرای حکم اعدام میلاد زهرهوند در رسانههای حقوق بشری، مانند ههنگاو و صفحه ۱۵۰۰ تصویر که اخبار اعتراضات پیگیری میکند، شنبه سوم تیرماه، محمدرضا عدالتخواه، رییس کل دادگستری همدان در نشست خبری بدون اینکه نامی از میلاد زهرهوند بیاورد، اعلام کرد «پرونده متهم قتل یک مامور امنیتی سپاه در کمتر از سه ماه بررسی و حکم قصاص او تایید شد و پرونده برای بررسی در اختیار دیوان عالی قرار گرفته است.»

با توجه به تناقضهایی که درباره نحوه کشته شدن علی نظری، کادر سپاه و عده متهمان پرونده در گزارشهای رسمی و سخنان مقامات استان همدان وجود دارد، سرعت بررسی پرونده میلاد زهرهوند نگرانیها درباره اعدام او را مانند دیگر معترضانی که در ماههای گذشته به همین شیوه اعدام شدند افزایش داده است.

به گفته منبع آگاه بیبیسی فارسی، میلاد زهرهوند در طی مراحل دادرسی از حق داشتن وکیل محروم مانده است.

از نحوه برگزاری دادگاه میلاد زهرهوند هم اطلاعی در دست نیست.

دستگیری

در ۴ آبان ۱۴۰۱، همزمان با چهلم مهسا امینی، دانشجویان دانشگاه ملایر، بر پایه فراخوانی که از پیش اعلام شده بود، دست به اعتراض زدند. به گفته نزدیکانش میلاد زهرهوند در میان معترضان نبوده است اما در آن روز به دلیل دیگری در محلی که یک عضو سپاه پاسداران به نام «علی نظری» در آنجا کشته شد، حضور داشته است .او به همراه چند نفر دیگر از اعضای فامیل خود در نزدیکی محوطه کلانتری ۱۲ ملایر بوده که درگیری با نیروهای امنیتی اتفاق افتاد. به گفته یکی از نزدیکان او «دست میلاد تیر خورد و به شدت زخمی شد. این عضو سپاه هم آنجا کشته شد.».

سپاه انصارالحسین استان همدان، علی نظری را عضو کادر اطلاعاتی-امنیتی سپاه پاسداران در ملایر معرفی کردهاست.[۱] اما تا کنون هیچ تصویر و سندی از سوی نهادهای حکومتی منتشر نشده است که نحوه کشته شدن این عضو سپاه پاسداران انقلاب اسلامی را نشان دهد و تناقضهایی نیز درباره این پرونده وجود دارد.[۲]

میلاد زهرهوند در تمام دوره بازداشت خود از حق دسترسی به وکیل و سایر حقوق ابتدایی یک متهم محروم بوده و در این مدت خانوادهاش به شدت از سوی سازمان اطلاعات سپاه تحت فشار قرار داشتند تا درباره او اطلاعرسانی نکنند. همچنین در خصوص برگزاری دادگاه او اطلاعاتی در دسترس نیست اما رییس دادگستری استان همدان از صدور حکم اعدام برای میلاد و ارسال حکم به دیوان عالی کشور خبر داده است.[۲] محمدرضا عدالتخواه، رییس کل دادگستری همدان هم بدون نام بردن از او گفته است «پرونده متهم سال گذشته در کمتر از سه ماه بررسی و حکم قصاص او تایید شد و پرونده برای بررسی در اختیار دیوان عالی قرار گرفت.»[۵]

حساب کاربری ۱۵۰۰ تصویر نیز اعلام کرده او در آبان ۱۴۰۱ «با سناریوی ساختگی قتل یک نیروی حکومتی» در ملایر بازداشت و به اعدام محکوم شد. $[rac{+1}{2}]$
