Narges Khorrami Fard was a dedicated lawyer known for her integrity

Narges Khorrami Fard, born on March 12, 1991, in Mashhad, was a dedicated lawyer known for her integrity and commitment to justice. She held license number 31997 and was a member of Tehran's Lawyers' Guild, although she primarily practiced in Mashhad.

After the tragic and cold-blooded murder of Mahsa Amini, Narges became actively involved in protests, demonstrating her unwavering support for the cause.

During the 2022-2023 Iran uprising, she fearlessly defended numerous young individuals who had been arrested or abducted, despite facing repeated threats and interrogations. Narges Khorrami Fard firmly believed in upholding her professional integrity and remained steadfast in her pursuit of justice.

Tragically, Narges was abducted in mid-November 2022 on Daneshjou Avenue in Mashhad.

Social media reports indicated that Narges was viciously tortured and poisoned.

On November 30, 2022, neighbors informed her family that her body had been abandoned outside their house. She did not have any IDs or phones on her. The clerical regime thus wanted to have her die outside the jail so that it would not have to account for her death. The Khorrami Fard family rushed Narges to the Nazeran Hospital in Mashhad.

At midnight, someone disguised as a doctor visited Narges and told her family that her condition was stable. He advised them to leave the hospital and return in the morning when she would be discharged.

However, the hospital staff saw two unknown men dressed as nurses enter her room and leave after some time. They reportedly gave her an injection, resulting in her death. Two hours later, her family was informed of her death.

The circumstances surrounding Narges' death were marred by intimidation as the hospital was surrounded by many security forces and vehicles belonging to the Special Guards Unit. The family was threatened to remain silent about Narges' death.

Narges Khorrami Fard was laid to rest on December 2, 2022, at Behesht-e Reza Cemetery. Before her burial, her family witnessed the bruising and scars on her body, evidence of her torture.

In her sacrifice, Narges Khorrami Fard joined the ranks of countless courageous and selfless women in Iran who have given their lives to pursue freedom and justice over more than four decades.

نرگس خرمی فرد متولد ۲۱ اسفند ۱۳۶۹ (۳۱ساله) در مشهد، وکیل پایه یک دادگستری با پروانه شماره ۳۱۹۹۷

نرگس خرمی فرد عضو کانون وکلای دادگستری مرکز بود ولی در مشهد کار می کرد. به گفته نزدیکانش، نرگس پس از قتل مهسا امینی هر روز برای اعتراض به خیابان می رفت.

وی وکالت جوانان بازداشتی و یا ربوده شده در جریان قیام سراسری ۱۴۰۱ را به عهده می گرفت و در دادگاه سرسختانه از آنها دفاع می کرد. بارها به خاطر این کار تهدید و حتی بازجویی شده بود اما او از شرافت شغلی اش دست نکشید.



نرگس خرمی فرد در یکی از روزهای آخر آبان، در خیابان دانشجوی مشهد توسط مأموران امنیتی ربوده شد.

بنا به گزارشاتی که در شبکه اجتماعی منتشر شد، نرگس را به شدت شکنجه کردند و با مواد سمی مسموم کردند.

خانواده اش نرگس خرمی فرد را به بیمارستان ناظران مشهد بردند. نیمه شب، پزشکی که او را ویزیت کرد به خانواده اش اطمینان داد که وضعیت او تثبیت است و از آنها خواست تا بیمارستان را ترک کنند و صبح برای ترخیص نرگس برگردند. اما کارکنان بیمارستان دیدند که پس از ترک خانواده، دو پرستار مرد ناآشنا وارد اتاق نرگس شدند و مدتی آنجا بودند. گفته می شود آنها به وی آمپولی تزریق کردند که موجب مرگ او شد.

دو ساعت بعد به خانواده خبر می دهند که نرگس فوت کرده است.

وقتی خانواده به بیمارستان برمی گردند تعداد زیادی از مأموران رژیم در بیمارستان بودند و چند ماشین یگان ویژه جلوی در بیمارستان پارک شده بود. مأموران خانواده را تهدید کردند که در مورد مرگ نرگس سکوت کنند.

نرگس خرمی فرد روز ۱۱ آذر ۱۴۰۱ در بهشت رضای مشهد بلوک ۶۲، ردیف۲ شماره ۲۸، به خاک سپرده شد. قبل از خاکسپاری، بر روی تن بیجان نرگس آثار کبودی و شکنجه رؤیت شده بود.

به این ترتیب نرگس خرمی فرد به زمره زنان پاکباز و شجاعی پیوست که بیش از ۴ دهه است در ایران جان خود را فدیه آزادی مردم و میهن شان کرده اند.

Narges Khorami is a capable and pure lawyer and an honorable human

Narges Khorrami Fard, born on March 21, 1369 (31 years old) in Mashhad, a basic lawyer of a judiciary with license number 31997

Narges Khorrami Fard was a member of the Central Bar Association, but he worked in Mashhad. According to her relatives, after Mehsa .Amini's murder, Narges went to the street every day to protest

He represented the youth arrested or kidnapped during the nationwide uprising of 1401 and stubbornly defended them in court. Many .times he was threatened and even interrogated for this, but he did not give up his job honor

.On one of the last days of November, Narges Khorrami Fard was kidnapped by security agents in Mashhad's student street

.According to the reports published on the social network, Narges was severely tortured and poisoned with poisonous substances

Narges Khorami is a capable and pure lawyer and an honorable human being

On December 9, 1401, the neighbors informed his family that he was left in front of the house, with a half-lifeless body and without a mobile phone or any documents with him. The regime wanted this murder not to happen in prison so that they would not be held

His family took Narges Khorrami Fard to Nazeran Hospital in Mashhad . At midnight, the doctor who visited her assured her family that her condition was stable and asked them to leave the hospital and return in the morning to discharge Nargis. But the hospital staff saw that after the family left, two unfamiliar male nurses entered Nargis's room and stayed there for a while. It is said that they injected him .with an ampoule which caused his death

.Two hours later, they inform the family that Nargis has died

When the family returned to the hospital, a large number of regime agents were in the hospital and several special forces cars were parked .in front of the hospital. The officers threatened the family to keep quiet about Narges' death

In this way, Narges Khorrami Fard joined the ranks of pure and brave women who have sacrificed their lives for the freedom of the people and their country in Iran for more than 4 decades
