SUSPICIOUS DEATH OF FORMER POLITICAL PRISONER

Sepideh Farahan (Farahabadi), a civil rights activist, was found dead in her home under mysterious circumstances in the Iranian city of Karaj, Alborz province. Sepideh Farahan was a former political prisoner who was released 2 years ago after serving 1,5 years for participating in the nationwide protests in 2017-2018.

Sepideh Farahan had previously stated in an interview: "During my detention at the Ministry of Intelligence detention center, they would give me 9 pills every day for 10 days. Later, when I investigated, I realized that the pills were withdrawal medication and were specifically for those with severe addiction to morphine..."

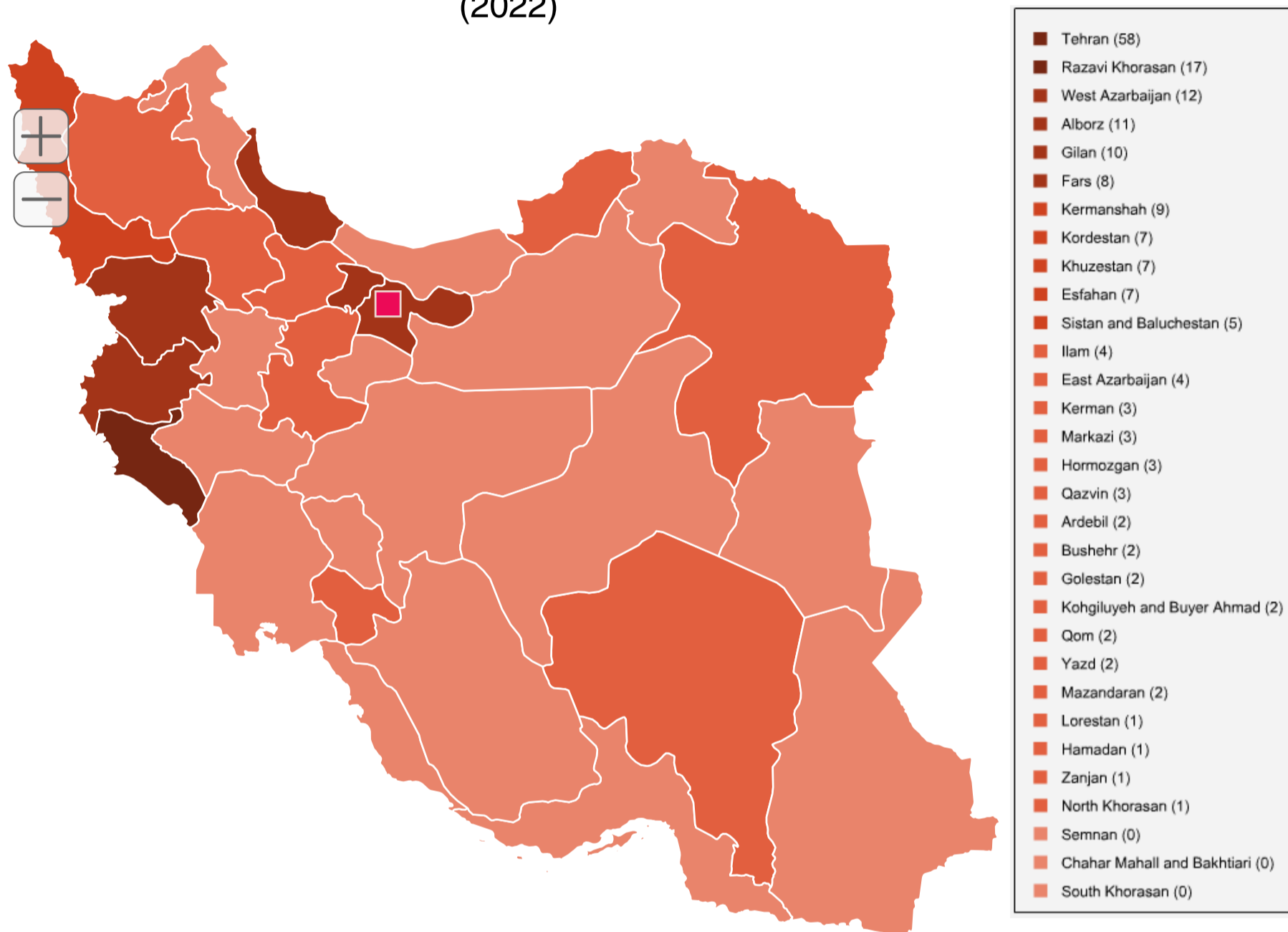

The lifeless body of Sepideh Farhan (Farahabadi), a former political prisoner, civil activist and one of the protestors of January 2016, was found in her personal home in Karaj on Friday, June 19, 2016. The cause of death is not yet known

Saeed Seifijehan, a former political prisoner, one of Sepideh Farhan's friends and co-accused, confirmed the death of this civil activist in an interview with BBC Farsi

According to Mr. Seifijehan, Sepideh Farhan was with her family for the last time on Wednesday, June 17, and after that no one saw her and she did not answer her family's calls

Mrs. Farhan was a resident of Karaj and was buried in Behesht Sakineh Cemetery in Karaj on Saturday, June 20.

The cause of Mrs. Farhan's death is still unknown and the family is waiting for the results of the forensic examination.

According to Saeed Seifijehan, when Sepideh Farhan's lifeless body was discovered in her home, there were no signs of suicide, and blood was flowing from her nose and mouth.

Protests on 96th day, arrest and imprisonment of Sepideh Farhan

On January 9, 2016, Sepideh Farhan, along with some of her friends, participated in the protests in front of Tehran University and was severely beaten by police officers on the same day.

A few days later, on January 12th, when he had participated in the protests for the umpteenth time, he was arrested along with several of his friends and transferred to the Deftar Peigeri detention center, one of the famous buildings of the Ministry of Information near Vali Asr intersection in Tehran.

Finally, after being interrogated in the follow-up office, he was taken to Evin prison with blindfolds and handcuffs.

Mrs. Farhan spent a total of 21 days in solitary confinement during her initial detention and was "finally accused by the investigation of Haft Evin branch with "Shahmohammadi

.Sepideh Farhan was temporarily released from Evin prison on bail until the end of the proceedings

Branch 26 of the Tehran Revolutionary Court, headed by Judge Ahmadzadeh, was responsible for handling the charges brought against this civil activist, and he was sentenced to six years in prison .and 74 Flogging was condemned

.The sentence issued against Mrs. Farhan in the appeals court was confirmed exactly

Later, Sepideh Farhan was told that there was a typographical error in the sentencing sheet, and her five-year prison sentence was reduced to two years on the charge of "community and collusion" .and she was acquitted of the charge of "disturbance of public order

.Finally, in December 2018, Mrs. Farhan was taken to Evin prison to serve her sentence

This former political prisoner was released in July 1400 with a leave attached to his freedom, after .enduring a year and a half imprisonment in Evin and Qarchak prisons in Varamin

Sepideh Farhan, a 28-year-old student of graphics, was arrested for the first time more than 2 years ago on 12 December 2016, during nationwide protests in Tehran's Revolution Square, by the agents of the Ministry of Information and transferred to Ward 209 of Evin Prison



Sepideh Farhan is one of the students who was arrested during the protests in January 2016. He was initially sentenced to six years in prison and 74 lashes on charges of "disturbance of public order by participating in illegal gatherings" and "assembly and collusion with the intention of committing against the security of the country", but his sentence was changed to two years in prison at the appeal court. In order to spend the prison term sooner, Sepideh presented himself for the execution of the sentences before the scheduled date, but now, despite his family's concern about the conditions of the prison prone to the spread of the corona virus, he has not yet been approved for his leave these days. One of Sepideh Farhan's friends narrated to us what happened to him and his family since January 2016

Unlike what was announced, Sepideh's final sentence is only two years, and in order to finish it sooner and be able to return to his studies and work, he introduced himself to prison on Tuesday 10 December 2018; But now and in a situation where Corona has endangered the lives of prisoners, contrary to the directive of the head of the judiciary and despite the request of her family, they have not given leave to Sepideh, whose sentence is less than 5 years





grant leave to prisoners in order to To prevent **the** spread of corona virus in prisons, **70,000 prisoners have gone on leave** .

According to Reihana, it is not clear why her imprisoned friend Sepideh Farhan was not included in the leave: "Sepideh has only a 2-year sentence and the provisions of the chief's directive definitely apply to her condition, but the request of Sepideh's ".family to grant her leave in this dangerous situation has not been accepted until now. "The moment has been ignored

Sepideh Farhan, a 28-year-old student of graphics, was arrested for the first time more than 2 years ago on 12 December 2016, during nationwide protests in Tehran's Revolution Square, by the agents of the Ministry of Information and transferred to Ward 209 of Evin Prison. According to Rehane, Sepideh Farhan was chased and beaten in the street on 9/1396, but they did not succeed in arresting him that day: "They were looking for him on 12/12, and as soon as he is identified, they will arrest him around 6:00 PM. His temporary detention lasted 47 days, of which he was kept in solitary confinement for 21 days on two occasions, and on February 28 of the same year, he was temporarily released from Evin prison by posting a bail of 250 .million tomans until the end of the proceedings

According to Rehane, during the interrogations, the agents use the telegram messages and coordination of Sepideh Farhan with her friends as the basis of their interrogations. In addition to these, both in the interrogations and in the indictment, some videos that Mrs. Farhan had published on her Instagram account of the several-day protests in January 2016 and her presence in these .protests were considered as evidence of her crime and the same are cited in the court

Reyhane says that Sepideh Farhan told her that they gave her pills in prison that led to her sleeping for a long time: "The first days when she was released from temporary detention, she seemed very scared and spoke to everyone very slowly and quietly, and more importantly, three Do not sleep at all on the first day. When she went to the doctor, when she told the doctor the name of the pill that was given to her in detention, the treating doctor said that this medicine is prescribed for those who are ".addicted to drugs, while Sepideh was not addicted

The trial of Mrs. Farhan, who was accused of "disturbance of public order through participation in illegal gatherings" and "assembly and collusion with the intention of committing against the security of the country", was held in absentia on July 3, 2019, in Branch 26 of the Revolution Court, presided over by Judge Mashallah Ahmadzadeh. Reyhane says that Sepideh did not have a lawyer: "Early on, Amir Raisian was Sepideh's lawyer, but under the pretext that he was not in the list of 20 lawyers of the judicial system, his representation was not accepted in the court. After that, Sepideh refused to have a lawyer, and of ".course, he did not appear in the primary court

Rehane says that on July 16, 2019, Ms. Farhan will receive the verdict of the court of first instance, according to which she will be sentenced to 1 year and 74 lashes for the charge of "disturbance of public order by participating in illegal gatherings" and 5 for the charge of "assembly and collusion with the intent to commit against the security of the country". He was sentenced to a year in prison: "Sapiedah himself wrote a bill of objection to this sentence and the case was referred to the 36th ".branch of appeal headed by Judge Ahmad Zargar

The court of appeals confirmed the verdict of the lower court on July 30th, without renewing the proceedings and summoning Mrs. Farhan: "As stated in the electronic judicial notification system, the court of appeals confirmed the verdict of Sepideh." .Rehane says that the news sites also reported on the approval of Sepideh Farhan's trial court verdict in the appeals court

But according to Reyhana, on August 2, when Sepideh and her mother went to the court in person to deliver the verdict, the verdict was changed: "When Sepideh and her mother went to Branch 36 to deliver the verdict, they were told to go to Branch 26. In the office of Branch 26, they give them an appeal verdict, which they had crossed out with a pen on 6 years of prison and the sentence of whipping, and wrote two years of prison instead. Rihane says that Sepideh and her mother thought that a mistake had happened at first, but the branch office manager said that the initial sentence was 2 years old and the appeal .confirmed the same

Reyhane says that the 47-day detention period of Sepideh Farhan in 2016 had a bad effect on her morale: "Among the e of that short period of detention, Sepideh was very annoyed with the existing situation, so much so that she did not ag

According to Reyhane, Sepideh Farhan's family hopes that with Sepideh Farhan's signature on the power of attorney, Mr. Nili will be able to take action to get her leave from prison: "Sepideh's mother has visited Evin prison several times from Karaj in recent weeks and has tried to get the supervising judge to visit the prison and has submitted the leave request to the prison; "But Sepideh's mother has not been able to see the judge until now, and her efforts to get a leave for Sepideh have been ".unsuccessful

Reyhane says that Sepideh Farhan insisted on going to prison early and that's why she turned to the Department of Execution of Sentences herself: "Sepideh said that she wants to finish her studies and university and then do some serious work, and she can't deal with the uncertainty caused by the uncertainty of the execution time of the sentence. Sepideh was supposed to report herself to prison on 26 February, but at her own insistence, she reported herself to prison 16 days before the scheduled time, .that is, on December 10

Now it is not clear why, despite the spread of Corona in the city and of course in the prisons of Iran, the leave of Sepideh .Farhan, who has all the conditions of the instructions for the leave of Raisi, is not approved

سپیده فرهان، زندانی سیاسی سابق و از بازداشت‌شدگان اعتراضات دی‌ماه ۹۶ درگذشت

پیکر بی‌جان سپیده فرهان (فرح‌آبادی)، زندانی سیاسی سابق، فعال مدنی و از معترضان دی‌ماه ۱۳۹۶، روز جمعه ۱۹ خرداد در منزل شخصی‌اش در کرج پیدا شد علت مرگ هنوز مشخص نیست.

سعید سیفی‌جهان، زندانی سیاسی سابق، از دوستان و هم‌پرونده‌ای‌های سپیده فرهان در گفت‌وگو با بی‌بی‌سی فارسی درگذشت این فعال مدنی را تایید کرد.

به گفته آقای سیفی‌جهان، سپیده فرهان آخرین بار روز چهارشنبه ۱۷ خرداد با خانواده‌اش بود و پس از آن کسی او را ندید و به تماس‌های خانواده‌اش پاسخی نمی‌داد.

خانم فرهان ساکن کرج بود و شنبه ۲۰ خرداد در آرامستان بهشت سکینه کرج به خاک سپرده شد.

هنوز علت فوت خانم فرهان مشخص نیست و خانواده در انتظار نتیجه پزشکی قانونی است.

به گفته سعید سیفی جهان، هنگامی که پیکر بی‌جهان سپیده فرهان در منزلش کشف شد، هیچ نشانه‌ای از خودکشی وجود نداشت، و از بینی و دهان او خون جاری شده بود.

اعتراضات دی ۹۶، بازداشت و زندان سپیده فرهان

سپیده فرهان ۹ دی ۱۳۹۶ به همراه تعدادی دیگر از دوستانش در جریان اعتراضات مقابل دانشگاه تهران شرکت کرد و همان روز به دست مأموران نیروی انتظامی به شدت مورد ضرب و شتم قرار گرفت.

چند روز بعد، در تاریخ ۱۲ دی ماه هنگامی که برای چندمین بار در اعتراضات شرکت کرده بود، به همراه چند تن از دوستانش بازداشت و به بازداشتگاه «دفتر پیگیری»، یکی از ساختمان‌های معروف وزارت اطلاعات در نزدیکی چهارراه ولی‌عصر تهران منتقل شد.

او نهایتاً پس از بازجویی در دفتر پیگیری، با چشم‌بند و دست‌بند به زندان اوین منتقل شد.

خانم فرهان در بازداشت اولیه خود جمعا ۲۱ را در سلول انفرادی سپری کرد و نهایتاً توسط بازپرسی شعبه هفت اوین با «شاه‌محمدی» تفهیم اتهام شد.

سپیده فرهان ۲۸ بهمن ۱۳۹۶ با قرار وثیقه به صورت موقت تا پایان مراحل دادرسی از زندان اوین آزاد شد.

شعبه ۲۶ دادگاه انقلاب تهران به ریاست قاضی احمدزاده مسئولیت رسیدگی به اتهام‌های مطرح شده علیه این فعال مدنی را به عهده داشت و او به اتهام «اجتماع و تبانی برای اقدام علیه امنیت ملی» و «اخلال در نظم عمومی» به شش سال حبس و ۷۴ ضربه شلاق محکوم شد.

حکم صادر شده علیه خانم فرهان در دادگاه تجدیدنظر نیز عیناً تایید شد.

بعدها به سپیده فرهان گفته شد اشتباهی تایپی در برگه صدور حکم وجود داشته و حکم پنج سال زندان او به اتهام «اجتماع و تبانی» به دو سال کاهش پیدا کرد و از اتهام «اخلال در نظم عمومی» تبرئه شد.

نهایتاً دی ماه ۱۳۹۸ خانم فرهان جهت گذراندن دوران محکومیت خود به زندان اوین برده شد.

این زندانی سیاسی سابق پس تحمل یک سال و نیم حبس در زندان‌های اوین و قرچک و رامین، تیر ماه ۱۴۰۰ با مرخصی متصل به آزادی به صورت کامل آزاد شد.

سپیده فرهان، دانشجوی ۲۸ ساله گرافیک اولین بار بیش از ۲ سال پیش در ۱۳۹۶ و در جریان اعتراضات سراسری در میدان انقلاب تهران به دست ماموران وزارت اطلاعات بازداشت و به بند ۲۰۹ زندان اوین منتقل شد. به گفته ریحانه، سپیده فرهان را روز ۹ دی ۱۳۹۶ در خیابان تعقیب کرده و کتک زده بودند اما آن روز موفق به بازداشت او نشده بودند: «روز ۱۲ دی دنبالش بودند و به محض این‌که شناسایی می‌شود حوالی ۶ عصر بازداشتش می‌کنند. بازداشت موقت او در آن مقطع ۴۷ روز طول کشید که ۲۱ روز آن را در دو نوبت در انفرادی گذارند و ۲۸ بهمن همان سال با سپردن وثیقه ۲۵۰ میلیون تومانی به صورت موقت و تا پایان مراحل دادرسی از زندان اوین آزاد شد.»

به گفته ریحانه، ماموران در جریان بازجویی‌ها، پیام‌های تلگرامی و هماهنگی‌های سپیده فرهان با دوستانش را مبنای بازجویی‌ها از او قرار می‌دهند. علاوه بر این‌ها، چه در بازجویی‌ها و چه در دادنامه، چند ویدیویی را که خانم فرهان از اعتراضات چندروزه دی ۱۳۹۶ و حضور خودش در این اعتراضات در حساب اینستاگرامش منتشر کرده بود به عنوان مدرک جرم او قلمداد کرده و در دادگاه هم به همان‌ها استناد می‌شود.

ریحانه می‌گوید سپیده فرهان به او گفته است در زندان قرص‌هایی به او داده‌اند که به خوابیدن طولانی‌مدت او منجر شده است: «روزهای اولی که از بازداشت موقت آزاد شد خیلی ترسیده به نظر می‌رسید و خیلی یواش و درگوشی با همه حرف می‌زد و مهم‌تر این‌که سه روز نخست را مطلقاً نخوابید. در مراجعه به پزشک هم وقتی نام قرصی را که در بازداشت به او خوراندند بودند به پزشک می‌گوید، دکتر معالجه می‌گوید این دارو برای کسانی تجویز می‌شود که سومصرف مواد مخدر دارند، درحالی‌که سپیده معتاد نبود.»

دادگاه خانم فرهان که به «اخلال در نظم عمومی از طریق شرکت در تجمعات غیرقانونی» و «اجتماع و تبانی به قصد ارتکاب علیه امنیت کشور» متهم شده بود، ۳ تیر ۱۳۹۸ در شعبه ۲۶ دادگاه انقلاب به ریاست قاضی «ماشالله احمدزاده» به صورت غیابی برگزار شد. ریحانه می‌گوید سپیده وکیل نداشت: «اوایل امیر ریسیان وکیل سپیده بود که به بهانه این‌که در فهرست ۲۰ نفره وکلای دستگاه قضایی نبود، وکالتش در دادگاه موردپذیرش قرار نگرفت. پس از آن هم سپیده از اختیار وکیل خودداری کرد و البته در دادگاه بدوی هم حاضر نشد.»

ریحانه می‌گوید ۱۶ تیر ۱۳۹۸ حکم دادگاه بدوی به خانم فرهان ابلاغ می‌شود که براساس آن بابت اتهام «اخلال در نظم عمومی از طریق شرکت در تجمعات غیرقانونی» به ۱ سال و ۷۴ ضربه شلاق و بابت اتهام «اجتماع و تبانی به قصد ارتکاب علیه امنیت کشور» به ۵ سال زندان محکوم شده بود: «سپیده خودش لایحه اعتراض به این حکم را نوشت و پرونده به شعبه ۳۶ تجدیدنظر به ریاست قاضی احمد زرگر ارجاع شد.»

دادگاه تجدیدنظر هم بدون تجدید دادرسی و احضار خانم فرهان، روز ۳۰ تیر حکم دادگاه بدوی را عیناً تایید می‌کند: «آن‌چنان‌که در سامانه ابلاغ الکترونیکی قضایی یا همان ثنا آمده بود، دادگاه تجدیدنظر حکم بدوی سپیده را عیناً تایید کرده بود.» ریحانه می‌گوید سایت‌های خبری هم بر همین اساس از تایید حکم دادگاه بدوی سپیده فرهان در دادگاه تجدیدنظر خبر دادند.

اما به گفته ریحانه، ۲ مرداد وقتی سپیده به همراه مادرش به صورت حضوری برای ابلاغ حکم به دادگاه مراجعه می‌کند حکم تغییر کرده بود: «وقتی سپیده و مادرش برای ابلاغ حکم به شعبه ۳۶ مراجعه می‌کنند به آن‌ها می‌گویند به شعبه ۲۶ بروند. در دفتر شعبه ۲۶، حکم تجدیدنظری به آن‌ها می‌دهند که با خودکار روی ۶ سال زندان و حکم شلاق آن خط کشیده بودند و دو سال زندان را به جای آن نوشته بودند.» ریحانه می‌گوید سپیده و مادرش ابتدا فکر می‌کنند اشتباهی رخ داده است، اما مسئول دفتر شعبه می‌گوید حکم اولیه ۲ سال شده است و تجدیدنظر هم همین را تایید کرده است.

ریحانه می‌گوید دوره بازداشت ۴۷ روزه سپیده فرهان در سال ۱۳۹۶ بر روحیه او تاثیر بدی گذاشته است: «ازجمله آثار آن دوره بازداشت کوتاه، آزدگی زیاد سپیده از وضعیت موجود بود، آن‌چنان‌که پس از رد وکالت آقای ریسیان در دادگاه حاضر نشد وکیل دیگری بگیرد. هرچند در روزهای اخیر و با توصیه همبندی‌هایش پذیرفته است وکیل بگیرد و آقای مصطفی نیلی وکالت‌نامه را برای امضای او تحویل قاضی ناظر زندان داده است.»
