Negar Karimian, 21-year-old woman killed by Iranian government forces in Lorestan

Negar Karimian, a 21-year-old young woman from Borujen, Chaharmahal and Bakhtiari province and a resident of Isfahan, was seriously injured by direct fire from the Iranian government forces and died hours later due to the severity of the injuries.

According to the report received by the Hengaw Organization for Human Rights, at around 1:00 am, on Saturday, March 9, 2024, the Iranian police forces opened fire on a civilian vehicle and killed one of its passengers at the intersection in Chaman Sultan City in Aligudarz district of Lorestan province, and as a result 21-year-old Negar Karimian, was killed.

According to a source close to the Karimian family, this family was returning to Isfahan from the funeral of their uncle in the village of Farsesh Aligudarz, when the police forces shot at her father's car (Peugeot 405) without any prior warnings. After firing directly, the bullet hit the driver's side door and then hit Negar's side and exited from the other side of her body. Negar Karimian's father also suffered a minor injury in this attack.

This source further added that Negar Karimian was taken to the "Imam Sadegh" Hospital in Aligudarz and died three hours later due to the severity of her injuries and internal bleeding. Another relative of this family told Hengaw: "The internal organs of the Abdominar were completely damaged in such a way that, according to the doctors, it was not possible to donate her body organs to other patients in need."

Hengaw has been informed that, after the murder of Negar Karimian, the Iranian police informed her family that they shot at their car by mistake.

It is worth mentioning that the funeral ceremony of Negar Karimian was held on Monday, March 11, at Bagh Rezvan cemetery in Isfahan.

Earlier, on the evening of Friday, January 19, 2024, the Iranian security forces shot at a car and killed a 20-year-old female student from Kohdasht, named Anahita Amirpour, in Borujard city in Lorestan province.

21-Year-Old Woman Latest Victim Of Iranian Security Forces

Iran's security forces have killed a 21-year-old woman in what law enforcement claims was a case of mistaken identity as she and her family drove home from a funeral in the early hours of Saturday.

Negar Karimian sustained injuries when law enforcement officers mistakenly fired at their moving car on Saturday and later died in hospital with severe internal bleeding.

The incident is the latest in **a series of deaths by Iran's security forces**. In a similar incident on June 9, a nine-year-old child lost his life after law enforcement officers fired at a van without warning. In January, Iranian security forces shot at a car and killed 20-year-old student Anahita Amirpour, also in Lorestan province.

According to HRANA, a total of 402 citizens were victims of military forces' shootings in 2023, with 120 deaths reported.

Explanation of "Etimad": Last week, the news of the death of a 21-year-old girl due to a mistaken shot by one of the police officers of the Chaman Sultan police station near a village with the same name in Aligudarz city, Lorestan province, became the media that "Etimad" reported for health and safety. Follows up. At the very

beginning, "Trust" tried to talk to the girl's father, mother and one of her sisters, but they stated that they could not be interviewed for some reason. While his uncle agreed to have a conversation with "Trust" about the details of the incident

According to Etemad, on the morning of Friday, the 19th of March this month, when "Ngar Karimian" along with his father, two sisters and the son-in-law of the family were returning to their place of residence from the funeral ceremony of their uncle in the village of Farsesh Aliguderz. were in Isfahan, suddenly he was shot by one of the police officers. In the meantime, the arrow first passes by the hand of the father of the family and then hits the side of this young girl. The hand of the father of the family is injured, and Negar also undergoes surgery after being transferred to Imam Jafar Sadiq Hospital, but after the operation, when he is transferred to the hospital's ICU, he dies due to internal bleeding

The news of the death of a young girl in Aligoders city, due to a wrong shot by a police officer, has created many questions in the minds of the grieving family of this young girl and the public opinion. The police chief of Aligudarz city announced on March 25th about this incident: "On the night of the accident, a Peugeot 405 car passed through without permission, regardless of

stop signs and the repeated warnings of the officers for the stop and inspection, which the officers assumed that this car contained drugs. It is narcotics, in order to seize the car, they shot from the air and in pursuit of the tire, one of the bullets hit one of the car's passengers, a young girl named Negar Karimian, and injured her


Meanwhile, the young girl's uncle says: "The police officer did not stop at all. My sister's husband has been a bus driver for forty years. It usually carries more than 30 passengers to their destination. How could he not have noticed the police stop?! Did he just get a certificate to say these things? Aliguderz, which is not Sistan and Baluchistan, where agents are lurking and even a car escapes. What has been said is not true. We will go to the end of revenge

Now, Negar Karimian's uncle has recounted the details of the night of the incident in an interview with "Trust


From whom did the police officer get the order to shoot

Mehdi Rezaei, uncle of the deceased, told "Etimad" about this incident: "One of my brothers died some time ago due to a heart problem. That's why my sister, her husband, three daughters and son-in-law of their family come to Farsesh village for the mourning ceremony. We are originally from Farsesh Aliguderz village. It was decided that after the funeral ceremony, my sister, Mother Nagar, will stay with our brother until the seventh ceremony, and her husband, my three nieces and my niece's wife will return to Isfahan. Because the little sister wanted to go to school. When they all get into the car, Negar sits in the front seat next to her father and her other two sisters sit in the back seat along with the son-in-law of the family. In the middle of the side road near the village of Chaman Sultan, one of the police officers, who also had a strong degree, shot at their car, which was a silver Peugeot 405. The bullet passed by my sister's husband's hand and hit Negar's left side and then hit the pillar of the car. They get out of the car and realize that an arrow was shot at Pahlavi Nagar. When the police officer sees the family inside the car, he quickly says that it was a mistake. While what's wrong?! How many cars were shot on that road? It is said that someone mistakenly told the wrong agent that a passing car was carrying drugs. Of course, this is what they told us. I myself asked the judge who was on duty, from whom did this officer get the order to shoot? The guard judge also said that I did not give the order to shoot. We don't understand if it is possible to shoot without orders from superiors

The expert stated that the distance between the bullet and the car was close

According to Negar's uncle, Negar's sister called him half an hour after the incident and said that they had an accident, but she did not tell him the truth of the incident and found out what happened inside the hospital. Rezaei says that Bozur Negar's sister described the night of the incident to him like this and said: "We were walking on a side road and a police officer's car was coming from the opposite side when we suddenly heard a noise. At first we thought something was thrown at the car or that we had an accident. My father braked to see what happened. My wife got out of the car while angry and said to the agent what did you do? Meanwhile, the police officer got out of the car and said; there has been a mistake. Then he asked; Are you all healthy?! My wife, who did not notice the shooting, asked the officer in response, "How?" The officer also said that he was shot. When the officer realized that the bullet hit Pahlavi Negar, he told us to just follow me. We went to the place where the Red Crescent forces were standing. There, we put Negar in their ambulance and the officer himself went in front of the ambulance until we reached Imam Jafar Sadiq Hospital

Mehdi Rezaei says: "Doctors quickly transfer Negar to the operating room, but after the surgery, when he was transferred to the ICU department, even though he had been injected with several units of blood, he ended up bleeding heavily. The bullet entered Negar's side from the left side and exited from his right side and hit the pillar of the car. The expert who came to visit the car announced; When the shot was fired, it was not far from the car and was fired almost from close range. This is not the first time that something like this has happened on this road. Four years ago, police officers killed a person named Shahram Rezaei in this way and said; The wrong shot was fired. The bullet hit Shahram Rezaei's heart and he died on the spot. He had a wife and children. A boy and a girl. After this incident, his son dropped out of school and went to work to support the family. Later, in justifying the shot that was mistakenly shot at this man, they said that he had an addiction and paid his ransom to the family. This time, our family was hit by a wrong shot and our young daughter lost her life

Three daughters. Negar was 21 years old and the second child of the family. Her older sister is married and her younger sister is also going to school

At first they said that the officer shot by mistake when there was no other car on the road, but then they said otherwise; They said that it was reported that the car that was traveling on the road was carrying drugs. .The officer could have blocked the car's path instead of shooting while it was moving

جزئیات جدید از چگونگی مرگ نگار کریمیان؛ دایمی نگار: مامور انتظامی اصلا ایست نداد

دایمی این دختر جوان (نگار کریمیان) در این مورد می‌گوید: «مامور انتظامی اصلا ایست نداد است. شوهر خواهر من چهل سال است که راننده اتوبوس است. اکثرا بیش از ۳۰ مسافر را به مقصد می‌رساند. چطور می‌شود ایست پلیس را متوجه نشده باشد؟! مگر تازه گواهی‌نامه گرفته بود که این حرف‌ها را می‌زنند.»

اعتماد آنلاین | بهاره شبانکارثیان-توضیح «اعتماد»: هفته گذشته خبر کشته شدن دختری ۲۱ ساله به دلیل شلیک اشتباهی یکی از ماموران نیروی انتظامی پاسگاه چمن سلطان در نزدیکی روستایی با همین نام در شهرستان الیگودرز استان لرستان رسانه‌ای می‌شود که «اعتماد» برای صحت و سقم خبر آن را پیگیری می‌کند. «اعتماد» در همان ابتدا تلاش کرد با پدر، مادر و یکی از خواهران دختر صحبت کند، اما آنها به دلایلی اظهار کردند امکان مصاحبه ندارند. در حالی که دایمی او حاضر شد در مورد جزئیات حادثه با «اعتماد» گفت‌وگویی داشته باشد.

به گزارش اعتماد، بامداد جمعه، نوزدهم اسفندماه جاری وقتی «نگار کریمیان» به همراه پدر، دو خواهر و داماد خانواده از مراسم خاکسپاری دایمی خود در روستای فرسش الیگودرز در حال بازگشت به محل زندگی‌شان؛ اصفهان بودند، ناگهان از سوی یکی از ماموران نیروی انتظامی هدف گلوله قرار می‌گیرد. در این میان تیر ابتدا از کنار دست پدر خانواده می‌گذرد و سپس به پهلوی این دختر جوان برخورد می‌کند. دست پدر خانواده مجروح می‌شود و نگار نیز پس از انتقال به بیمارستان امام جعفر صادق تحت عمل جراحی قرار می‌گیرد، اما بعد از عمل هنگامی که به بخش‌ای سی‌یو بیمارستان منتقل می‌شود به خاطر خونریزی داخلی جانش را از دست می‌دهد.

خبر جان باختن دختر جوان در شهرستان الیگودرز آن هم با شلیک اشتباهی مامور نیروی انتظامی سوالات زیادی در ذهن خانواده داغدار این دختر جوان و افکار عمومی ایجاد کرده است. فرمانده انتظامی شهرستان الیگودرز ۲۵ اسفندماه جاری در رابطه با این اتفاق اعلام کرد: «شب حادثه یکدستگاه خودرو پژو ۴۰۵ بدون توجه به علائم ایست و بازرسی و اخطارهای مکرر ماموران برای ایست و بازرسی به‌طور غیرمجاز عبور کرده که ماموران به فرض اینکه این خودرو شامل مواد مخدر است، جهت توقیف خودرو اقدام به تیراندازی هوایی و در تعاقب به سمت لاستیک خودرو کردند که یکی از گلوله‌ها پس از اصابت به بدنه خودرو به یکی از سرنشینان خودرو که دختر جوانی به نام نگار کریمیان بود، برخورد و موجب جراحت او شد.»

این در حالی است که دایمی این دختر جوان در این مورد می‌گوید: «مامور انتظامی اصلا ایست نداد. شوهر خواهر من چهل سال است که راننده اتوبوس است. اکثرا بیش از ۳۰ مسافر را به مقصد می‌رساند. چطور می‌شود ایست پلیس را متوجه نشده باشد؟! مگر تازه گواهی‌نامه گرفته بود که این حرف‌ها را می‌زنند. الیگودرز که سیستان و بلوچستان نیست که ماموران در کمین باشند و یک ماشین هم فرار کند. حرف‌هایی که گفته شده صحت ندارد. ما تا پای قصاص پیش خواهیم رفت.»

حالا دایمی نگار کریمیان در گفت‌وگو با «اعتماد» جزئیات شب حادثه را بازگو کرده است.

مامور انتظامی از چه کسی دستور شلیک گرفته بود؟

مهدی رضایی، دایمی جان باخته در مورد این حادثه به «اعتماد» می‌گوید: «یکی از برادرانم چند وقت پیش به خاطر مشکل قلبی فوت می‌کند. برای همین خواهرم، همسرش، سه دختر و داماد خانواده‌شان برای مراسم عزاداری به روستای فرسش می‌آیند. ما اصالتا اهل روستای فرسش الیگودرز هستیم. قرار شد بعد از مراسم خاکسپاری، خواهرم یعنی مادر نگار تا مراسم هفتم برادرمان بماند و شوهرش، سه خواهرزاده‌ام و همسر خواهرزاده‌ام به اصفهان برگردند. چون خواهر کوچک نگار می‌خواست به مدرسه برود. وقتی همگی سوار ماشین می‌شوند، نگار صندلی جلو کنار پدرش می‌نشیند و دو خواهر دیگر او به همراه داماد خانواده صندلی عقب می‌نشینند. وسط جاده فرعی نزدیک روستای چمن سلطان یکی از ماموران انتظامی که درجه استواری هم داشته به ماشین آنها که پژو ۴۰۵ نقره‌ای بود، شلیک می‌کند. تیر از کنار دست شوهر خواهرم رد می‌شود و به پهلوی چپ نگار اصابت و سپس به ستون ماشین برخورد می‌کند. آنها از ماشین پیاده و متوجه می‌شوند تیر به پهلوی نگار شلیک شده است. وقتی مامور نیروی انتظامی می‌بیند خانواده داخل ماشین بوده، سریع می‌گوید اشتباه شده است. در حالی که چه اشتباهی؟! مگر در آن جاده چند ماشین بود که اشتباه شلیک شده باشد؟ می‌گویند شخصی به اشتباه به همان مامور خاطی گفته بود ماشینی که در حال گذر است، مواد مخدر حمل می‌کند. البته این طوری به ما گفتند. خود من از قاضی کشیک پرسیدم این مامور از چه کسی دستور شلیک گرفته بود؟ قاضی کشیک هم گفت من دستور شلیک ندادم بودم. ما متوجه نمی‌شویم مگر می‌شود بدون دستور مافوق، شلیک کرد!»

کارشناس اعلام کرد فاصله تیر با ماشین نزدیک بوده است

به گفته دایمی نگار نیم ساعت بعد از این حادثه خواهر نگار با او تماس گرفته و گفته که تصادف کردند، اما اصل ماجرا را برای او تعریف نکرده و داخل بیمارستان متوجه شده چه اتفاقی افتاده است. رضایی می‌گوید که خواهر بزرگ نگار شب حادثه را برایش اینگونه تعریف کرده و گفته: «ما داشتیم در جاده فرعی می‌رفتیم و ماشین مامور نیروی انتظامی هم داشت از مقابل می‌آمد که یک دفعه صدایی شنیدیم. اول فکر کردیم چیزی به سمت ماشین پرت شده یا اینکه تصادف کردیم. پدرم ترمز کرد تا ببینیم چه اتفاقی افتاده است. همسرم در حالی که عصبانی بود از ماشین پیاده شد و به مامور گفت که چه کار کردی؟ در همین حین مامور نیروی انتظامی هم از ماشین پیاده شد و گفت: اشتباه شده است. بعد هم پرسید: همه سالم هستید؟! همسرم که متوجه تیراندازی نشده بود در جواب مامور از او پرسید، چطور؟ مامور هم گفت شلیک شده است. وقتی مامور متوجه شد تیر به پهلوی نگار برخورد کرده، به ما گفت که فقط دنبال من بیایید. تا جایی رفتم - که نیروهای هلال احمر ایستاده بودند. آنجا نگار را سوار آمبولانس‌های آنها کردیم و خود مامور هم جلوی آمبولانس ر به بیمارستان امام جعفر صادق رسیدیم.»

مهدی رضایی می‌گوید: «پزشکان، نگار را سریع به اتاق عمل منتقل می‌کنند، اما بعد از جراحی وقتی به بخش ای سی یو منتقل می‌شود با وجود اینکه چند واحد خون به او تزریق شده بود از شدت خونریزی تمام می‌کند. تیر از سمت چپ وارد پهلوی نگار شده بود و از سمت راست پهلوی او خارج و به ستون ماشین برخورد کرده بود. کارشناسی که برای بازدید از ماشین آمده بود، اعلام کرد؛ وقتی تیر شلیک شده، فاصله زیادی با ماشین نداشته و تقریباً از فاصله نزدیک شلیک شده. این اولین بار نیست که در این جاده چنین اتفاقی می‌افتد. چهار سال پیش هم ماموران نیروی انتظامی یک نفر به اسم شهرام رضایی را اینگونه کشتند و گفتند؛ تیر اشتباه شلیک شد. تیر به قلب شهرام رضایی برخورد کرد و او هم درجا جان باخت. او زن و بچه داشت. یک پسر و دختر. پسرش بعد از این اتفاق درس را رها کرد و رفت کارگری تا بتواند مخارج خانواده را تامین کند. بعد هم در توجیه تیری که به اشتباه به این مرد شلیک شده بود، گفتند او اعتیاد داشته و دیه‌اش را به خانواده پرداخت کردند. این بار هم که شلیک اشتباهی دامن خانواده ما را گرفت و دختر جوان‌مان جانش را از دست داد.»

رضایی همچنین به سوالات دیگر «اعتماد» پاسخ می‌دهد.

Two-Year-Old Killed In Iran As Police Open Fire At Family Car

A two-year-old child was killed on Friday after Iranian special forces opened fire at the car carrying him and his family in the central city of Esfahan.

The "1500 Images" Twitter account reported that "Last night [Friday], a mother and father with two young children were traveling in a car when a truck belonging to the special unit swiveled in front of them. The driver of the car (a family friend) thought the truck driver was sleepy, so he decided to go around the truck. But the special forces opened fire at them and killed the child by shooting him in the head."

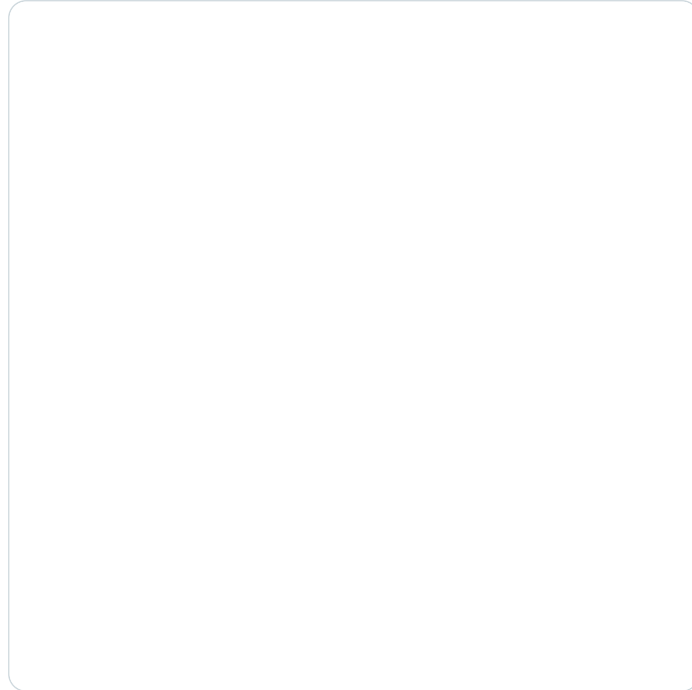
"Bazaar Civil Protest" Telegram channel identified the child as Amirali Musa-Kazemi, adding that he was killed as his family and several friends were on a recreational trip to Esfahan.

According to the report, the special unit's vehicle was a "truck unlike police cars" and the forces in it fired at the car without warning them to pull over.

It remains unclear why the special police unit opened fire at a car carrying ordinary citizens and children.

It is stated in the report that Amir-Ali's body was not handed over to his family under the pretext of handing it over to them in Tehran. The cause of death was registered as "unintentional murder".

Police officials are yet to react to the report.

This is not the first time children are killed by regime forces' direct fire in private cars.

In the most controversial case, Kian Pirfalak, a 9-year-old child from Izeh in the south, **was killed by the** direct fire of government forces during nationwide protests on November 16.
