Iranian Protester Commits Suicide Amidst Allegations Of Torture

Alireza Khari, a protester who was released from prison in Iran, has taken his own life allegedly due to relentless security pressures.

Khari, detained previously for burning a picture of Supreme Leader Ali Khamenei in front of the Revolutionary Guards (IRGC) headquarters, reportedly faced torture during his captivity.

Having been arrested in September 2022, Khari endured 40 days of solitary confinement and three months in prison. After his release, he was repeatedly summonsed and interrogated by the IRGC.

In the wake of the 2022 protests sparked by Mahsa Amini's death, close to 20,000 Iranians were apprehended by government authorities either during or in the intervals between protest periods. While a number have been subsequently released, a handful have succumbed to mysterious and premature deaths.

In a similar vein, other incidents earlier have happened involving Iranian protesters. Yalda Aghafazli, a 19-year-old protester died in April last year under mysterious circumstances after her release from prison, with tests revealing narcotics in her system. Meanwhile, Arshia Emamgholizadeh, a 16-year-old arrested for a minor offense, ended his life shortly after release, due to the trauma inflicted during his detention.

Such incidents highlight the grave human rights violations and the toll they take on the mental and physical well-being of Iranian citizens.

Information received by Iran International indicates that Alireza Khari, a young protester from Bandargaz in Golestan province and one of the protesters arrested in the revolutionary uprising, committed suicide and died due to continuous .security pressure

Alireza Khari, a young man born in the 70s, was arrested and tortured on the charge of setting fire to the photo of Ali .Khamenei, the leader of the Islamic Republic, in front of the IRGC headquarters in Bandargaz city

.His funeral was held in his hometown on Tuesday, March 29

The information received by Iran International indicates that this young protester has been imprisoned in the "Amirabad" .prison of Gorgan, the capital of Golestan province, for about three months since October 1401

He was sentenced to two years in prison by the judiciary, but later he was placed on the list of Khamenei's amnesty .order

However, after his release, this young protester was summoned and interrogated many times by the intelligence of the

The funeral ceremony of Alireza Khari was held in his native village "Koh Sahra". The security atmosphere dominated .the event and security officers and vehicles were present to control the situation

The death of this former political prisoner and protester comes at a time when there were reports of the suspicious .death of some other protesters after their release

Maryam Arvin, a lawyer, was one of these people. He was also in charge of representing a number of protesters who .were arrested once and died after being released in 1401



.His family was also under security pressure during this time

Among other names in this field is Amirhossein Terwal Iman . He was one of the detainees of the nationwide protests who was granted amnesty and released after about eight months of detention, but he died suspiciously after a few .days



Ashkan Baloch, a kickboxing athlete, a former political prisoner and one of the detainees of the revolutionary uprising,

was one of these people who died suspiciously

Reports show that agents and security and intelligence agencies continue to pressure protesters and political prisoners .even after they are released

علیرضا خاری، جوان معترض بازداشتشده در بندرگز، در پی فشارهای امنیتی پس از آزادی خودکشی کرد

اطلاعات رسیده به ایران اینترنشنال حاکی است که علیرضا خاری، جوان معترض اهل بندرگز در استان گلستان و از معترضان بازداشتشده در خیزش انقلابی، در پی فشارهای مداوم امنیتی خودکشی کرده و جان باخته است.

علیرضا خاری، جوان متولد دهه هفتاد، به اتهام آتش زدن عکس علی خامنهای، رهبر جمهوری اسلامی، در مقابل مقر سپاه پاسداران در شهرستان بندرگز بازداشت شد و تحت شکنجه قرار گرفت.

مراسم تدفین او روز سهشنبه ۲۹ اسفندماه در زادگاهش برگزار شد.

اطلاعات رسیده به ایران اینترنشنال حاکیست این جوان معترض از مهرماه سال ۱۴۰۱ به مدت حدود سه ماه در زندان «امیرآباد» گرگان، مرکز استان گلستان، محبوس بوده است.

او از سوی قوه قضاییه، به دو سال حبس محکوم شد، اما بعد در فهرست دستور عفو خامنهای قرار گرفت.



مراسم خاکسپاری علیرضا خاری در روستای زادگاهش «کوه صحرا» برگزار شد. جو امنیتی بر این مراسم حاکم بود و ماموران و خودروهای امنیتی برای کنترل شرایط در آن حضور داشتند.

مرگ این زندانی سابق سیاسی و معترض در حالی است که پیش از این نیز گزارشهایی از مرگ مشکوک برخی دیگر از معترضان پس از آزادی منتشر شده بود.

مریم آروین، وکیل دادگستری یکی از این افراد بود. او وکالت شماری از معترضان را نیز بر عهده داشت که یک بار بازداشت و پس از آزادی در سال ۱۴۰۱ درگذشت.



خانواده او نیز در این مدت تحت فشار امنیتی بودند.

از دیگر نامها در این زمینه امیرحسین تروال ایمان است. او از بازداشتشدگان اعتراضات سراسری بود که پس از گذشت حدود هشت ماه بازداشت، با برگزاری دادگاه مشمول «عفو» و آزاد شده بود، اما بعد از چند روز به شکل مشکوکی درگذشت.



اشکان بلوچ، ورزشکار رشته کیکبوکسینگ، زندانی سیاسی سابق و یکی از بازداشتشدگان خیزش انقلابی هم یکی از این افراد بود که به صورت مشکوکی جان خود را از دست داد. گزارشها نشان میدهد که ماموران و نهادهای امنیتی و اطلاعاتی حتی پس از آزادی معترضان و زندانیان سیاسی، آنها را تحت فشار میگذارند.

Alireza Khari, an arrested protester, died ."due to "double security pressure

Alireza Khari, one of the detainees of the nationwide protests of 1401 in Bandar ."Gaz, was buried after a "suspicious death

Based on the pictures published from the obituary of this young protester, his funeral ceremony was held in the presence of security officers on Tuesday, March .29, in Koh Sahra village, Bandar Gaz, Golestan province

According to human rights sources, Alireza Khari committed suicide due to "pressure from security institutions". He had been summoned and interrogated .many times before by the intelligence of the Islamic Revolutionary Guard Corps

After being arrested, this protester was tortured for allegedly burning Ali .Khamenei's photo

According to the campaign for the defense of political and civil prisoners, he was in solitary confinement for 40 days at the time of his arrest and in Amirabad prison .in Gorgan for about three months

This is not the first time that an arrested protester has died a suspicious death shortly after being released from prison

Ashkan Baloch , Yalda Aghafazli and Arshia Imam Qolizadeh, Maryam Arvin, Mohsen Jafarirad and Hasti Hossein Panahi are among the detainees who died of suspicious deaths after being released from prison

Mistreatment" in the prisons of the Islamic Republic and the deprivation of political prisoners from proper medical facilities have been repeatedly criticized by the United Nations and human rights defenders

علیرضا خاری، معترض بازداشتی، در پی «فشار مضاعف امنیتی» جان باخت

علیرضا خاری، از بازداشتشدگان اعتراضات سراسری ۱۴۰۱ در بندر گز، پس از «مرگ مشکوک» به خاک سیرده شد.

بر پایه تصاویر منتشرشده از آگهی ترحیم این معترض جوان، مراسم خاکسپاری او در حضور ماموران امنیتی در روز سهشنبه ۲۹ اسفند، در روستای کوه صحرا، از توابع بندر گز در استان گلستان، برگزار شده است.

به گزارش منابع حقوق بشری، علیرضا خاری در پی «فشار نهادهای امنیتی» دست به خودکشی زد. او پیشتر نیز بارها از سوی اطلاعات سپاه پاسداران انقلاب اسلامی احضار و بازجویی شده بود.

این معترض پس از بازداشت، به اتهام آتشزدن عکس علی خامنهای تحت شکنجه قرار گرفته بود.

به گزارش کمپین دفاع از زندانیان سیاسی و مدنی، او در زمان بازداشت چهل روز در سلول انفرادی و حدود سه ماه هم در زندان امیرآباد گرگان محبوس بود.

این نخستین بار نیست که یک معترض بازداشتشده مدتی پس از آزادی از زندان به مرگ مشکوک جان باخته است.

اشکان بلوچ، یلدا آقافضلی و عرشیا امامقلیزاده، مریم آروین، محسن جعفریراد و هستی حسین پناهی از جمله بازداشتشدگانی هستند که پس از آزادی از زندان به مرگهای مشکوک جان باختهاند.

«بدرفتاری» در زندانهای جمهوری اسلامی و محرومیت زندانیان سیاسی از امکانات پزشکی مناسب، بارها مورد انتقاد سازمان ملل و مدافعان حقوق بشر قرار گرفته است.
