## Iranian lawyer: A woman sentenced to death was hanged after a heart attack

March 1, 2019 - February 19, 2021

One of Zahra Ismaili's lawyers says that her client suffered a heart attack in Rajaeeshahr prison before the execution of the death sentence, but the .prison authorities hanged him

Zahra Ismaili was once found guilty and sentenced to death for the murder of her husband Alireza. It is said that Mr. Zamani was one of the agents of .Iran's Ministry of Intelligence

.Mrs. Esmaili was executed on Wednesday 29th of February along with several other people

.Attorney Omid Moradi says that Zahra Esmaili had a stroke after seeing the execution of several men before the execution of the sentence

.Mr. Moradi said that in the death certificate of Mrs. Esmaili, "cardiac arrest" was mentioned as the cause of death

He wrote: "16 people hanged the man before Zahra and in front of her eyes. Before Zahra went to the gallows, she had a stroke and her heart stopped and she died. However, they hanged her lifeless body... The victim's mother personally He sat on a stool to see his bride's body on the gallows even for a ".few moments".



Alireza was introduced as one of the agents of the Ministry of Information

.Mr. Moradi said that contrary to published reports, the number of executioners in Rajai Shahr prison on Wednesday was 17, not seven

."He said that Zahra Ismaili's wife "was one of the general managers of the Ministry of Information, not a simple officer of the Intelligence Department

By sharing a family photo of Zahra Ismaili, Mr. Moradi wrote about Alireza Zamani, the victim: "Zahra's family has this one photo of her. Zahra's wife was ".not satisfied that there was any photo of her in her parents' house

Two weeks ago, Didarnews wrote about this case: "Apparently, the murder was committed by the victim's daughter and by the father's handgun. Until Zahra took responsibility for the murder, all three family members were in prison. Since 2017, many efforts have been made The parents' consent was ".obtained, but in the end the victim's mother did not consent

After China, Iran has the highest number of executions in the world, and Iran's judiciary has been repeatedly condemned by the United Nations and .human rights activists for the widespread use of the death penalty and other harsh punishments, as well as the lack of a fair trial

.Ebrahim Raisi, the head of Iran's judiciary in 1367, was directly responsible for the secret and sudden execution of thousands of political prisoners
