# Prisoner died after being flogged for drinking alcohol in Iran

A young prisoner died after being flogged for drinking alcohol in the city of Ahar in northwestern Iran. He was identified as Hadi Attazadeh.

Hadi Attazadeh passed away a few hours after being flogged in Ahar Prison, northwest Iran. Footage of his funeral and footage showing marks of his lashed back was also published in the report.

The Chief Justice of Eastern Azarbaijan Province denied reports of the man dying from flogging and said "initial investigations showed that the most likely cause of death was drug poisoning" and "abdominal pain". Musa Khalilollahi did not provide further details on how Hadi Attazadeh obtained the medicine.

However, his family denied this claim.

In an interview with VOA, the man's brother Qasem Attazadeh said they were informed on August 30 that Hadi was transferred to [redacted] sem Attazadeh said he became unwell after being flogged and when he was taken to the hospital two days later, it was too late.

"The Chief Justice of Eastern Azarbaijan said he passed away from abdominal pain and the prison told us he died from COVID-19. All of these are lies. They killed him," he said.

Qasem Attazadeh said his brother was detained for possession of alcoholic beverages and had been sentenced to one and a half years of prison. He also said his brother was completely healthy.

The Iranian authorities continue to allow such ruthless punishments and to justify them in the name of protecting religious morals.

Article 265 of Iran's Islamic penal code states that the punishment for consumption of alcohol by a Muslim is 80 lashes.

More than 100 other offences are punishable by flogging, including theft, assault, vandalism, defamation and fraud, as well as acts should not be criminalised, such as adultery, intimate relationships between unmarried men and women, "breach of public morals" and consensual same-sex sexual relations.

Article 179 of Iran's Penal Code provides for a mandatory death sentence following the third conviction for drinking alcohol.

Iranian authorities [executed a man](#) in July 2020 for "drinking alcohol" in Mashhad Central Prison in Razavi Khorasan province. He was [identified](#) as 55-year-old Mortaza Jamali.

## Hadi Atzadeh, a young man from Ahri, died from whipping in prison

Hadi Atzadeh, a citizen of East Azarbaijan province, a resident of Ahar city, died a few hours after being whipped by the officers of the Ahar judiciary and being transferred to the prison of this city. Information about this young man's crime, the number of whippings inflicted on his body, and the day of his death have not been published yet. As can be inferred from the obituary notice of Hadi Atzadeh, his body was buried on Tuesday, September 9th, in "Ayatollah Barqi" cemetery in Ahar city, and he probably died the day before, on September 8th.

Wednesday, September 10, 1400, equal to September 1, 2021

Hadi Atzadeh, a young resident of Ahar, died in prison quarantine a few hours after the execution of the whipping sentence. A video of his body while being washed in the washroom has been published, which shows multiple blows of the whip on the body of this young man.

Information about this young man's crime, the number of lashes inflicted on his body, and the day of his death have not yet been published.

ANT" news website has published a video from the Ahar laundromat, which shows the body of Hadi Atzadeh while being washed, and numerous lashes can be seen on the body of this young man. Kahan London refuses to publish this video due to the heartbreaking and horrific nature of the torture inflicted on the young body of this citizen.



As the human rights account "1500 Images" reported, this young man was transferred to the quarantine of Ahar prison a few hours after the .execution of the sentence of whipping, the number of which has not been announced, and he died inside the prison

The judicial authorities have claimed to deal with the violence against the prisoners in this prison, and at the same time, in contradictory statements, they consider violence against the !prisoners to be a common thing in the prisons of the world

In the meantime, public opinion believes that violence and torture against prisoners and detainees is an organized and planned policy, and it .takes place with the full knowledge of all judicial institutions, prisons and the first person of Ali Khamenei's government

وبسایت خبری «ای‌ان‌تی» فیلمی را از غسلخانه‌ی اهر منتشر کرده که پیکر هادی عطازاده را هنگام شستشو نشان می‌دهد و ضربات متعدد شلاق بر پیکر این جوان دیده می‌شود. کیهان لندن به دلیل دلخراش و هولناک بودن شکنجه‌ای که بر پیکر جوان این شهروند اعمال شده، از انتشار این ویدیو خودداری می‌کند.



آنگونه که اکانت حقوق بشری «۱۵۰۰ تصویر» گزارش داده، این جوان چند ساعت پس از اجرای حکم شلاق که تعدادش اعلام نشده، به قرنطینه‌ی زندان اهر منتقل شده و در داخل زندان جان خود را از دست داده است.
