## Biography of Ruhollah Ajamian of Basij who was killed in Karaj

.Ruhollah Ajamian was a member of the Basij force who was killed in the Karaj riots



**Event 24** Seyyed Ruhollah Ajamian was an active member of the Basij forces in the 417th Martyrdom of Kamalshahr, Karaj. During the unrest that occurred after the death of Mahsa Amini in Iran, he was one of the forces that, along with other Basij and military forces, confronted the people on the street

### Biography of Ruhollah Ajamian

Ruhollah Ajamian was born on 20 Bahman 1374 in Kohdasht, Lorestan province, and lived in Karaj. During the protests that took place on November 12, 1401 in Karaj, there was a fierce conflict between the military forces and the people, and in one of these conflicts, Ruhollah Ajamian was stabbed to death. The gathering of people was on the 40th day of the killing of Hadith Najafi in Karaj, when the events took place on that day. Hadith Najafi was a daughter of Karaj who died on 30th of Shahrivar 1401 in Karaj. The judiciary announced that he died of natural causes and had nothing to do with the protests

Ajamian was active in karate sports and has a 1st dan black belt in ninja ranger technical field. His family says that he had also registered to participate in the Syrian war, but he could not go there

### Accused of the murder of Ruhollah Ajamian

In the hearing of the murder case of Ruhollah Ajamian, the prosecutor's representative stated the names of the defendants as follows: " **Mohammed Mehdi Karmi** is accused of corruption in the world through crimes against the country's security, attacks on Basiji agents, gatherings and collusion against the country's security, publishing calls against the regime. He has been arrested online. "Mohammed Mehdi Karmi, along with **Ali Moazzami** , **Reza Shaker** and **Najib .Mohammadi** , left Nazarabad and came to Karaj to participate in illegal gatherings

Some people who have been accused in this case have denied their accusations; About the attack of Dr. Hamid Qarahasanlu, who said during the hearing that "he and

his wife went to Sakineh Paradise in Karaj to attend the grave of an acquaintance and ".planned to attend the same day if a ceremony was held for Hadith Najafi



### How to kill Ruhollah Ajamian

During the conflict that took place on Thursday, November 12, 1401, on the road leading to Behesht Sakineh Karaj, Ruhollah Ajamian, one of the Basij forces, was present at the scene. Ajamian was caught by another group in one of the scenes where the conflict between the two sides escalated and led to shooting, and he was killed in that scene. The film that was released from the scene of the killing of Ajamian had many reflections. The judiciary has released a video of the confession of the assailants of Ruhollah Ajamian. In this film, there are also scenes of how Ajamian .was killed

روح الله عجمیان عضو نیروی بسیج بود که در ناآرامی‌های کرج به قتل رسید.



رویداد ۲۴ سید روح الله عجمیان عضو فعال نیروهای بسیج در حوزه ۴۱۷ شهدای کمالشهر کرج بود. در جریان ناآرامی‌هایی که در پی درگذشت مهسا امینی در ایران رخ داد، یکی از نیروهایی بود که به همراه دیگر بسیجیان و نظامیان با افراد حاضر در خیابان مقابله می‌کرد.

### بیوگرافی روح الله عجمیان

روح الله عجمیان متولد ۲۰ بهمن ۱۳۷۴ در کوهدشت استان لرستان است که در کرج زندگی می‌کرد. در جریان اعتراضاتی که روز ۱۲ آبان ۱۴۰۱ در کرج شکل گرفت، درگیری شدیدی میان نیروهای نظامی و مردم رخ داد که در یکی از این درگیری‌ها روح الله عجمیان به ضرب چاقو به قتل رسید. تجمع مردم در روز چهارم کشته شدن حدیث نجفی در کرج بود که اتفاقات در آن روز رخ داده است. حدیث نجفی دختر کرجی بود که روز ۳۰

شهریور ۱۴۰۱ در کرج جان باخت. قوه قضاییه اعلام کرده او به مرگ طبیعی درگذشته و ربطی به اعتراضات نداشته است.

عجمیان در رشته ورزشی کاراته فعالیت می‌کرده و دارای کمر بند مشکی دان ۱ در رشته فنی نینجا رنجر بوده است. خانواده‌اش می‌گویند او برای حضور در جنگ سوریه هم ثبت نام کرده بود، اما نتوانسته بود به آنجا برود.

## متهمان قتل روح الله عجمیان

نماینده دادستان در جلسه رسیدگی به پرونده قتل روح الله عجمیان اسامی متهمان را چنین بیان کرده است: «محمد مهدی کرمی به اتهام افساد فی الارض از طریق جرایم علیه امنیت کشور، حمله به ماموران بسیجی، اجتماع و تبانی علیه امنیت کشور، انتشار فراخوان علیه نظام در فضای مجازی بازداشت شده است. محمد مهدی کرمی به همراه علی معظمی، رضا شاکر و نجیب محمدی از نظرآباد خارج و برای حضور در تجمعات غیر قانونی به کرج آمده است.»

### نحوه قتل روح الله عجمیان

در جریان درگیری که روز پنج شنبه ۱۲ آبان ۱۴۰۱ در مسیر منتهی به بهشت سکینه کرج رخ داد، روح الله عجمیان از نیروهای بسیجی حاضر در صحنه بود. عجمیان در یکی از صحنه‌ها که درگیری میان دو طرف زیاد می‌شود و کار به تیراندازی می‌کشد، توسط گروه دیگر گیر می‌افتد و در آن صحنه به قتل می‌رسد. فیلمی که از صحنه کشته شدن عجمیان منتشر شده، بازتاب زیادی داشت. قوه قضاییه فیلمی از اعترافات ضاربان روح الله عجمیان منتشر کرده است. در این فیلم صحنه‌هایی از نحوه قتل عجمیان نیز وجود دارد.

## Iran Issues Heavy Sentences To Protesters Accused Of Killing Agent

Fourteen protesters have been jailed in Iran for up to 15 years for the death of a Basij agent in a trial branded a travesty of justice by human rights activists.

Ruhollah Ajamian was killed in Karaj, near Tehran, in November by a group of men the regime called "rioters".

The member of the Basij militia of the Revolutionary Guards (IRGC) was stabbed, beaten, and stripped naked by a group of men and died of his injuries later.

The Islamic Republic has already executed Mohammad Mehdi Karami and Mohammad Hossein over Ajamian's death.

On Tuesday in Alborz, 14 protesters were jailed in connection with the killing, with five of them receiving long-term prison terms of 10 and 15 years.

The two executions came after a hasty trial and without their right to choose a lawyer.

Jurists and human rights activists have described the trials as “unfair” and questioned the verdicts.

The judiciary of Alborz province claimed on Tuesday that the charges leading to the verdict were not "intentional murder" but "corruption of the earth" and "moharebeh", or “waging war against God”.

Among the defendants, Hamid Qarahasanlou, who was previously sentenced to death, received the longest prison term and was given 15 years in prison. He is set to serve his sentence in Yazd province in central Iran.

These are only the latest lengthy sentences to be handed down by the Iranian regime to countless protesters in the widespread demonstrations that followed the death in custody of 22-year-old Mahsa Amini last September.

Protests broke out in scores of cities across Iran, with crowds demanding justice for Mahsa and calling for an end to the regime’s oppressive policies.

The brutal crackdown in response to the demonstrations and heavy sentences handed out by the courts have signaled the regime’s refusal to change and determination to silence dissent.
