Maryam Arvin, a lawyer, was arrested while defending her client in court and died suspiciously shortly after her temporary release.

The mother of Maryam Arvin, a lawyer who committed suicide shortly after being released from prison, was found dead in prison.

Tayyaba Nazari wrote on Instagram on Monday, Khordad 8th, that her daughter, who was arrested for defending Mulek, was "tied up" and "destroyed" in prison "under the pretext of sedation, pain relief and strengthening".

He says that the prison doctor had confirmed the names of the injuries suffered by Maryam Arvin.

Tayyaba Nazari also emphasized that a week after her daughter's death, the 103rd Criminal Branch issued a sentence of "15 months in prison, one million [Tomans] fine, and 40 lashes" for her in absentia. Hss is attached to him

According to her mother, 29-year-old Maryam Arvin was a volunteer lawyer for "cases of the underprivileged" and "welfare children and working children" who "had not been married for more than two months."

Mrs. Arvin was a member of the Bar Association of Kerman province. On December 9, 1401, he was arrested in Sirjan court while defending his clients who were among the arrested protesters in Kerman.

The judicial authorities also arrested his mother, Tayyaba Nazari, who had gone there for follow-up.

and Adar Maryam Arvin was born on the 21st day of Falzad, but she died suspiciously.

In the past months, a number of those detained in nationwide protests have died suspiciously after their release, and the cause of their death has been declared as "suicide".

The death of several prisoners after their release, such as Mohsen Jafarirad, Arshia Imamqolizadeh, Yalda Aghafazli, and Beshen Pahi Peshahi, has created a great deal of concern about the fate of prisoners.
